3. Meeting Notes

Chicago Meeting update:

Diane reported that about 280 people registered, 180 IEEE, 60 CIGRE and 40 Companion.

Standards (S0) update:

Hamid Sharifnia informed that 8 PAR's are going to expire in 2011: 979, 1677, 1246, 1127, 998, 1712, 81 and 1031. Hamid agreed to maintain the complete standards list with the status, for example when the PAR expires.

It was suggested that we do not hand out too many awards. Awards should be limited to people with major contributions.

The title of the Minutes for Meeting was changed to Meeting Notes.

The timing and length of the A0 meeting was discussed. It used to be on Thursday. Joe Gravelle requested to cut the A0 meeting duration to allow the various subcommittee meetings in the morning before the Awards Lunch. This was approved by the executive committee.

Appeals update:

PAR 998: The appeals panel has been formed with 3 members. John McDonald is the chair. This panel will hear procedural appeals. The technical appeals are through the balloting process.

C0 Scope: The proposed revised scope of C0 was approved with some modifications.

New approved C0 scope:

The subcommittee and its working groups and task forces are responsible for treatment of all matters relating to data acquisition, processing and control systems within substations. These systems include transducers, Intelligent Electronic Devices (IEDs), Human Machine Interfaces (HMIs), and communication networks. These matters include the low-level interfaces to and protocols communicating locally and remotely with these systems. Cyber security and the environmental phenomena that can adversely affect these systems are included.



The subcommittee supports similar work being done in other standards development organizations working on smart substations.

6. Membership Report



Markus Etter reported that membership is approx. 396. This includes 7 life members, 334 active members and 79 committee members.

The secretary received over 150 e-mail rejections when the registrations were sent out. The database contains over 1000 names. It was decided not to terminate these entries but rather unselect the automatic e-mail announcement. The secretary agreed to perform this ask over the next several month.

No membership reports for the subcommittees and working groups will be created and printed by the secretary any more.

7. Financial Report

Markus Etter gave the financial report. At the beginning of May 2011 the balance was about \$61,000. This is not enough to cover the projected deficit. Additional moneys will the requested from the present sponsor and additional sources. Hermann Koch and John Randolph are coordinating this effort.

The cost for Thursday's dinner with CIGRE was picked up by sponsors rather than the Substations Committee.

8. Updated Brochure

The brochure now includes the standard number(s) that the working group is responsible for. Hamid Sharifnia will keep this database.

9. UHV Joint Standards

PAR 1860/61/62 is sponsored by IEEE-SA Board of Governors/Corporate Advisory Group (BOG/CAG). The Substations Committee is a joint sponsor. These are entity ballots. Mr. Du Zhigang, State Grid Corporation of China (SGCC) is the chair for all three working groups.
