- 7. Items still requiring comments and/or identified at this meeting include:
 - Joe needs further guidance for Section 7.6 Segregation. Some other comments received may cover this item.
 - Annex M has been re-assigned to Pathik Patel. Comments due by February 1, 2013.
 - Dale Fox needs to be contacted for outstanding assignments. Need comments by February 1, 2013. Deb will contact Dale.
 - Dewan Jamir needs to complete comments for Annex J Jamming Ratio.
 Comments due by February 1, 2013. Deb will contact Dewan.
 - Discussed the need for possible clarification of definitions for low voltage and medium voltage by the Working Group. Re: Paragraph 8.3. Also are the installation requirements in the Guide in line with other codes and standards. For instance, single layer of individual cables verses triplex in trays. Need to find the source of the current paragraph 8.3 and consider expanding for intent and content. WG to comment by February 1, 2013.
 - Discussed the need for a Section 9 for Future cables. Deb will check historical documents for the intent of Section 9 for future cables. John Randolph believed this was only used as a placeholder.
- 8. Large Station Example: Alan G. gave a review of the Appendix P status for the large station example. Much of the text, Conduit Plan, data tables, and calculations have been significantly worked on. Some cleanup and finalization is remaining. Assignment is for the Large Station Task Force to have the final edits of the large station example completed by January 15, 2013 ready for review.
 - The Large Station Single Line needs more detail to match the level of detail shown on the Small Station example.
 - Diane W. will revise Appendix P Figure 4 for the Large Station SCADA diagram. Assignment preferred to be completed by January 1, 2013, but absolute by March 1, 2013.
