February 7, 2000 Executive Committee Meeting Minutes

- 1. Report and Approval of Minutes from Previous Meeting- Ralph Bruce
 Randy Bruce called the meeting to order at 6:32 pm. He welcomed everyone to the year 2000 sessions and
 explained the new meeting format in which the Chapter chairs started the reports, rather than the other
 executive committee members. He stressed the need for Chapter participation as the Chapters are the
 main reason of this sections's existence. There were 17 attendees, including the Chairs of all local
 Chapters. Attendees reviewed the January 14, 200 minutes and it was approved without changes.
 - Eastern Shore Section was dissolved and members are now part of the Annapolis sub-section. \$3486.86 transferred to the Baltimore Section treasury.
 - Fall edition of WATTS NEW is ready and will be the last full paper publication. New editions will be on the web and can be downloaded. Members desiring paper copies could still request it on a case by case basis. An annual announcement with web addresses and ballot will still be sent by postal mail.

- a. Aerospace and Electronic Systems (AES-10) Mark Brown (2000 Chair). Invited group to attend their 11 February meeting on "Multirate Digital Signal Processing Tutorial" at Northrop Grumman. He needs RSVP by Feb 9 and meeting is free to members. He will send in an L-31 report by e-mail.
- b. Anten. and Propag./Microw. Theory and Tech. (AP-03/MTT-17) -Howard Fudem (1999 Chair). Howard reported that AP/MTT meetings now being planned within the next two months. The local chapter received some funding in December. Last year, they had technical meetings in April, May, and October.
