- 1. The meeting started at 6:30PM
- 2. The section chair sent a status report to region 2.
- 3. The chair reported that all chapter has a minimum of two meetings, this was achieved by having some joint meetings between chapters. It was suggested that we have technical presentations at the section meeting to make a joint meeting with a chapter
- 4. The vice chair set up a mailing list for those who attend the section meeting.

 - e. Randy Bruce reported that the section logo, the "Sky Crab," should be trademarked. A motion to approve trademarking was approved, Randy will get information on the cost of doing this.
 - f. Dave Boyd reported on electronic kits supplied by the naval academy primarily for the use of the middies to learn soldering. There is a field trip to Oceaneering. Merrill Skolnick will be the speaker at a future meeting.
 - g. Bill Dixon had nothing to report on PACE. He requested volunteers to be judges to for the robot challenge paper evaluation.
