
Membership Report

IEEE IAS Atlanta Attendance



IEEE IAS Atlanta - Member Attendance





- Global Supply Decreased (COVID-19 Pandemic Restricted Business Activity)
- Global Firms Rely on Non-Diversified Supply Chains
 - Lean Manufacturing (Just-In-Time Inventory)
 - Reliance on China for various goods
- Shifts in Consumer Activity
- Demand Distortions (Bullwhip Effect)
- Supply Chains are Complex Networks of Interconnected Factors
- Supply Chain Issues Affect All Sector




Effects

- Shortage of Production Capacity Around the World
- A Vicious Cycle of Scarcity (Raw Materials, Components)
- Overwhelmed Manufacturing and Logistics
- Long lead-times
- Price increases



Unfilled Orders and Inventories Up 50% in Dollars, Not So In Actual Product In a first, the dollar value of unfilled orders has exceeded inventories due to drawdowns and rapid inflation





How Hard is to Disrupt the Supply Chain?

The Great Toilet Paper Shortage of 1973

- Harold Froehlich, a congressman, releases a statement saying, 'The next thing we're gonna have to worry about is a potential toilet paper shortage,'"
- Johnny Carson makes a joke about it during the Tonight Show on 12/19/73
- People all over the country stormed supermarkets, grabbed as much toilet paper as they possibly could.

How are we dealing with the current situation?

- Postponing Projects and Purchase Decisions
- Buying pre-owned equipment
- Releasing equipment during early stages of design



Electrical Supply Chain Projections

Material	Reason for Shortage	Price Change (Delta +/-)	Pre- Pandemic Lead Time	Current Lead Time
Electrical Switchgear, UPSs, & Transformers	Conductor and Steel Shortages	+ 5% - 10%	3-6 months	10-14 months
Panelboards	Conductor and Steel Shortages	+ 10% - 15%	4-10 weeks	2-5 months
Switches, Circuit Breakers, Fuses, Relays, etc.	Shortage of Insulation Resin and Semiconductors	+ ≤ 25%	6-8 weeks	10-40 weeks
Conduit Fittings, Metal Conduit, Metal Boxes, etc.	Shortage of Metals and Plastics Fossil Fuels	+ 10% - 30%		
Wires & Cables	Shortages of Copper and Aluminum	+ 2% - 12%		
Generators	Shortage of Steel, Electrical Components	+ 20%	3-6 months	Up to 18 mo



Electrical Supply Chain Projections

Material	Recommendation		
Electrical Switchgear & Transformers	Consulting with 2nd and 3 rd tier manufactures Pre-order equipment during design phase Consider alternative designs		
Panelboards	Stock up and factor 10-15% above current pricing into 30-day project bids.		
Switches, Circuit Breakers, Fuses, Relays, etc.	While a slight increase in product availability is likely to return toward the end of Q2, the price for breakers likely to hold or slightly increase in Q2 with potential relief in 2023		
Conduit Fittings, Metal Conduit, Metal Boxes, etc.	Stock up and factor 10-15% above current pricing into 30-day project		
Wires & Cables	bids. Consider fiberglass conduit as an alternative.
