## **INVESTORS' CORNER**

The purpose of this column is to provide investment information pertinent to CN Member needs and is the first of a planned series of articles. #### THE ABCs OF BOND INVESTING

To achieve your investment goals, it's important to allocate your assets in a way that creates a diversified portfolio. Many investors use bonds as the foundation of their balanced portfolios because bonds offer a wide range of maturities (duration periods), interest payment terms and credit quality that fits most investors' needs.

#### **Back to Basics: What Is a Bond?**

In its simplest terms, a bond is an IOU. It represents a loan by you (as one of the bondholders) to an issuer (a corporation, municipality or government agency). Bondholders lend money to the issuer in return for the promise of fixed periodic payments of interest and the repayment of the loan's principal amount at maturity.

#### **Bond Prices and Interest Rates**

The market price of a bond has an inverse relationship to the movement of interest rates. When interest rates go up, bond prices go down and vice versa. Just as interest rates fluctuate daily, so do the prices of bonds prior to maturity. When you buy a bond and hold it until its maturity, you don't have to worry about its price changing because you'll receive the full face value of the bond at maturity. However, if you need to sell a bond before its maturity date, the price you receive may be more or less than your original price or the bond's maturity value.

Since a bond's interest rate is fixed when you buy it, a change in interest rates will affect the value of your bond if you were to sell it prior to its maturity. For example, if you bought a \$10,000 bond with an 8% coupon and interest rates dropped from 8% to 4%, your bond would become more valuable than those subsequently issued at lower interest rates. Therefore, prior to maturity you could sell your bond at a *premium* to its face value. On the other hand, if rates rose to 12%, investors would want to own new issues that pay more interest, and your bond would lose some of its resale value. If you sold it under this scenario, it would be at a *discount*.

#### **Evaluating Bond Risks and Returns**

In assessing the level of risk and return of any fixed income investment, the following two factors are important.

**Maturity**. Your bond's maturity is the date on which the principal amount becomes due and payable to you. The number of years until the bond matures will dictate the bond's sensitivity to changes in interest rates. Generally, you are compensated with higher yields for longer-term securities because the longer a bond has until it matures, the longer its principal value is exposed to interest rate fluctuations. Bonds with short-term maturities (overnight to one year) normally experience relatively minimal change in price as interest rates fluctuate, but they also typically provide relatively lower yields. Intermediate bonds (2 to 10 years) typically have greater yields and price fluctuations. Long-term bonds, which typically mature in 20 to 40 years, usually have higher yields but can also experience greater price fluctuations.

**Quality.** The credit quality rating of a bond provides an indication at a particular point in time of an issuer's ability to make timely payments of interest and principal to bondholders. Two nationally recognized rating agencies, Standard & Poor's

Corporation and Moody's Investors Service, measure a bond's credit quality by assigning it a letter grade, ranging from AAA for the highest quality to D for a bond in default. Bonds rated at least BBB by S&P or Baa by Moody's are considered "investment grade." Lower-quality bonds generally have higher yields but also have a greater potential for default. Ratings are constantly revised based on related industry or company changes and can have a distinct effect on a bond's market price.

Your challenge as a bond investor is to obtain the highest possible return with the least risk, in line with your investment objectives. Many fixed income investors "ladder" their bond investments by structuring a portfolio of bonds with staggered maturities. By diversifying investments in short-term, intermediate and long-term bonds in a ladder portfolio, you can take advantage of the liquid aspects of the shorter-term bonds while attaining the higher yields typically available through longer-term bonds.

## PENTAGON SEEKS IDEAS ON COMBATING TERRORISM

Having trouble deciding how you can help fight terrorism? Well here may be an opportunity to apply your technical skills to this problem. The Department of Defense announced today that the Under Secretary of Defense for Acquisition, Technology and Logistics and the Combating Terrorism Technology Support Office Technical Support Working Group are jointly sponsoring a Broad Agency Announcement (BAA) asking for help in fighting terrorism.

The BAA, issued Oct. 23 (No. 02-Q-4655), specifically seeks help in combating terrorism, defeating difficult targets, conducting protracted operations in remote areas, and developing countermeasures to weapons of mass destruction. Its objective is to find concepts that can be developed and fielded within 12 to 18 months.

The BAA provides for a three-phase process in which interested parties initially submit a one-page description of their concept. Initial responses are due by Dec. 23, 2001. After a review of a submission and if DoD is interested in further information, the submitter will then be asked to provide a more detailed description of up to 12 pages of the idea. Submitters of concepts that the department is not interested in pursuing further will be so notified.

The DoD will evaluate phase two submissions and ask those who have offered the most promising ideas to submit full proposals in a third phase that may form the basis for a contract. Phase two submitters who are not asked to submit full proposals will be so notified. Submitters of a full phase three proposal that is not accepted by the department may request a formal debriefing. Debriefings will not be provided to phase one and phase two submitters whose concepts were not accepted.

## **IN MEMORIAM – Harry Staubs**

Harry Staubs, OCCN Member and Board Member at Large for nearly a decade, passed away in his sleep on the night of October 18, 2001, in Cleveland OH. His last trip was typical of what he liked to do best, interfacing with people and friends, at the Tau Beta PI (National Engineering Honor Society) Convention. Harry was a strong believer in engineering, the military-industrial complex, and the ability of human organizations to solve problems and improve mankind. An example of this is a listing of the immense number of organizations that benefited from his active participation and leadership. A considerably shortened list of these organizations and achievements include: National Defense Service Medal; AIAA – Associate Fellow, past Chairman of the Orange County Section, and Chairman of the Get-Away-Special Project; Fellow of the Institute for Advancement of Engineering; Orange County Engineering Council; Air Force Association, National Space Society: Toastmasters International; California Museum of Science - Industry Foundation; Society for the Advancement of Materials and Process Engineering; Tau Beta Pi, CSLB Visiting Professor for Get-Away-Special class, and, CALSAT (the AIAA California Synergistic Acquisition Technology Transfer Organization).

Mr. Staubs first career was with the US Air Force (1952-1980) where he achieved the rank of Lieutenant Colonel. His many assignments took him all over the world, but his greatest achievements were in the management of research and development projects in the Rocket Propulsion field with projects requiring as many as 100 Air Force and contractor personnel. His second career was with McDonnell Douglas (1987-1992) as a Senior Staff Specialist, Test Manager, and marketer, primarily in the rocket propulsion and space system fields. His third career was with Staubs Business Services specializing in McIntosh and PC hardware, software and office automation support to small businesses. SBS is also well known for their many philanthropic activities in the service of the above listed technical organizations.

Probably one of the more recent examples of his organizational leadership skills were his contributions to CALSAT, both as a founding member and nearly a decade as Chairman. The original mission of this AIAA sponsored volunteer organization was to provide member support with career transition efforts through networking and information related to consulting, new business development, and entrepreneurial opportunities. As the organizational needs changed from the Aerospace Industry recession of the early nineties, he gradually steered it to more entrepreneurial pursuits. How this organization will change in Harry's absence is the subject of the next CALSAT meeting (see Calendar Section).

Mr. Staubs received his BS in Chemical Engineering from West Virginia University, did MS level studies at Columbia U, received an MBA from Cal State Long Beach, and is a graduate of the Joint Command and Staff School of the Armed Forces Staff College.

Less than a year ago Harry had open-heart surgery, including a valve replacement and bypasses, and appeared to have completely recovered in a matter of a few weeks. His death was preceded by that of his wife Virginia approximately 13 months ago. He is survived by a brother in West Virginia. Harry, we all miss you.

Program Description: Reliability programs were developed in the '50s when failures of increasingly complex military		

electronic systems became a problem. These same techniques were then adapted for electrical power generation and distribution. This concern for reliability, availability, and maintainability (or RAM) has grown and has been applied to avionic systems, process systems, water plants, and situations where failures represent a high risk or a major expense.

Today, we are using an improved set of tools to deliver the reliability and availability needed for our e-commerce. High availability is probably the most important metric for data centers and online firms. Their availability, measured in terms of four 9s, five 9s, and six 9s, is widely touted, but difficult to demonstrate.

Bob Gauger will share with you the experience and techniques that he has used in 40 years of system reliability, availability, and maintainability analysis, modeling, prediction, testing, and corrective action. These systems have ranged from telecom, data centers, and diesel generators to complete installations with cooling towers, HVAC, steam generation, and multiple power sources.

### Closing Some of the "Loop Holes"

After last week's Attack On America, I have given much thought to the controlling the "Loop Holes" in this country.

**Highjacking Aircraft** - First, control of Pilot Training facilities. Any city or town has one or more airports housing one or more flying schools. At these flying schools one or more persons may have the following training:

- Ground School six months to one year
- Flight Training six months minimum Visual Flight Rules (VOR) only
- VFR or Instrument Rating/Training -six months to one year.

To graduate from VOR (Line Of Sight) to VFR, a prospective pilot must show a minimum number of hours in his log book and good comprehension of Training Manuals.

The FAA needs to tighten up their controls over these schools and whom they teach. The FAA needs to document the Instructors and the students. Training should only be provided to U.S. Citizens, not foreign nationals.

**Pay Attention** - Each of us must be more aware and alert of our surroundings. If you think that certain activities are not normal for the time and place, let the authorities know.

Third, when requests are made by airport officials regarding your safety, don't willfully disregard those rules. They are for your safety!

### PLANNED GPS CIVIL SIGNALS AND THEIR BENEFIT TO THE CIVIL COMMUNITY - October 18, 2001

by A. J. Van Dierendonck, AJ Systems

In March 1998, two major enhancements to the Global Positioning System directed at civilian users worldwide were announced. These were a second civil code on L2 and a third civil signal (later designated at L5 in 1999) for safety of life services. Since that time, the details of modernization have been largely worked out. The complete modernized GPS signal structure includes the addition of the military's earth coverage and spot beam M-Codes on L1 and L2, the addition of the civil C/A code (and/or the L2CS code) on L2, and the introduction of the entirely new civil frequency and code at L5. In addition, the characteristics of the existing GPS signals will remain the same, at least as they affect the civil community. For example, all existing geodetic receivers will perform without disruption, as nothing will change on the current L2 P/Y Code and L1 C/A and P/Y Codes.

The new civil signals will greatly benefit the diverse civil community. The new receivers using the new signals will perform significantly better. After summarizing the characteristics of the new signals, this presentation will detail the benefits of these new signals to a representative set of civil applications. It will also detail some of the current problems for civil GPS receivers in adverse environments, and it will describe how the new signals alleviate those problems. The Southern California Institute of Navigation Section is pleased to announce this meeting on Thursday, October 18 from 12 noon to 1:00 p.m.. #### **Program Description:**

Reliability programs were developed in the '50s when failures of increasingly complex military electronic systems became a problem. These same techniques were then adapted for electrical power generation and distribution. This concern for reliability, availability, and maintainability (or RAM) has grown and has been applied to avionic systems, process systems, water plants, and any place that failures represented a high risk or a major expense.

Today, we are using an improved set of tools to deliver the reliability and availability needed for our e-commerce. High availability is probably the most important metric for data centers and online firms. Their availability, measured in terms of four 9s, five 9s, and six 9s, is widely touted, but hard to demonstrate.

Bob Gauger will share with you the experience and techniques that he has used in 40 years of system reliability, availability, and maintainability analysis, modeling, prediction, testing, and corrective action. These systems have ranged from telecom, data centers, and diesel generators to complete installations with cooling towers, HVAC, steam generation, and multiple power sources.

## **AICN REGISTRATION**

For those LAACN and OCCN members who have not yet registered in the Alliance of IEEE Consultants' Networks database, we strongly encourage you to do so. Among the newly available opportunities available in the process is an increase in the number of words available for describing capabilities and background to 200. This provides a more robust marketing capability for consultants. Kip Haggerty has developed a summary of the different registration processes for the LAACN and OCCN members that supplies all the "how to" directions. Part of it is reproduced below with minor changes for the convenience of the readers. A list of frequently asked questions associated with this process compiled by Kip is also included.

#### OCCN: How to Join/Renew in 7 easy steps:

- 1. Send a \$95 check to the Treasurer (if not up to date on dues). If up to date on dues, skip this step.
- 2. If joining, submit an application see http://www.occn.org/join.htm
- 3. Go to the IEEE-USA Directory http://www.ieeeusa.org/consultants/
- 4. Register if joining
- 5. Enter or Update Listing
- 6. Select "OCCN" as your Local Network
- 7. Select "Pay By Check" The OCCN will pay your AICN registration fee in bulk.

To Join Both LAACN and OCCN - follow the instruction for OCCN and then select both OCCN and LAACN as the local directory.

## FREQUENTLY ASKED QUESTIONS:

- 1. If I renew and am in OCCN, do I need to pay IEEE-USA?
- A: No. Select "Pay By Check" as your payment option. OCCN will pay the directory fee for all OCCN members in good standing (i.e. dues up to date).
- 2. If I renew and am in LAACN, do I need to pay IEEE-USA?
- A: Yes. Paying the directory fee to IEEE-USA and selecting LAACN as your local network is all that is required to renew your membership in LAACN (or join). It is recommended that you pay by credit card because it is easier and is secure because it is encrypted and not stored on a server.
- 3 What if I am a member of both OCCN and LAACN?
- A: You should verify that your dues are up to date with OCCN and pay OCCN if they are not. OCCN will use its dues receipts to pay for its full members to be placed in the IEEE-USA National Directory. When updating your listing, please verify that both networks are selected. You will have to scroll through the list. If either is not selected, then correct your listing before submitting.

- 4. How do I select more than one local network?
- A: Select the first by clicking on it. Select additional networks by holding down the Command (Mac) or Control (Win) Key and clicking on the next selection.
- 5. If I renew with LAACN and pay IEEE-USA, what do I have to pay LAACN?
- A: Nothing. If you select a local network, part of the fee is rebated to that local network (or networks). There is no additional cost for selecting LAACN and no directory fee discount for not selecting a local network. LAACN operates with the Directory rebate and an Affinity Group rebate from the Los Angeles Council and currently charges no additional fees for membership.
- 6. If I renew with OCCN or my OCCN dues are up to date, how much do I pay IEEE-USA?
- A: Nothing. OCCN will be using the dues it collects to pay for each of its full members (not associate members) to be in the IEEE-USA Directory.
- 7. Why are the two networks using different payment approaches?
- A: Legacy. LAACN aligned its dues with the IEEE-USA directory year several years ago. As a result, it is easiest for LAACN to simply not collect dues directly and focus on promoting the directory itself. OCCN never adopted "calendar year" dues and has memberships due for renewal throughout the year. However, OCCN has committed to placing all it's full members in the IEEE-USA directory as well as serving its associate members who are not listed in the directory. For these reasons, it is easiest for OCCN to continue to collect dues locally and pay for the directory listings in bulk.
- 8. I can't log in to renew/update my listing. What is wrong?
- A: User names and passwords are case sensitive. The default user name is your email address as listed in the 2000 directory (printed copy and web directory). If you have upper case letters in your email address like the first person in the 2000 Directory (Andrew@InventorOne.com) and you enter your user name in all lower case, you will be rejected. The solution is to enter the default user name exactly as shown in your 2000 listing.
- 9. Netscape on Windows explodes and crashes when submitting form data. What is wrong?
- A: It is believed that versions around 4.73 have stability problems. Please upgrade to 4.76 or later.
- 10. How much is the IEEE-USA National Directory renewal/join fee?
- A: IEEE-USA Directory annual registration fee is \$75 for IEEE Members of any grade and \$99 for nonmembers (2001 prices).
- 11. I heard that that Local Consultants' Network Incentive Plan has changed. What is new?
- A: In the past a network would be eligible for a \$15 discount off the regular member subscription if every member of its Network joined the database. This entailed having to process registrations locally, do detailed bookkeeping, and, usually, to pay for each member's registration in the national database. This year, the process becomes much simplified. In addition, the discount will increase, and it will no longer be necessary for the network to register every one of it's members, have its registrations in by a tight deadline, or have to process its members' registrations. Here is how the new system will work:
  - Network members register individually on the system.
  - Networks will select a local administrator.
  - The local administrator will be able to monitor and download local network data.
  - Networks apply for a rebate from IEEE-USA based upon their membership.
  - For 20-49 members registered, \$20/registered member goes to the network.
  - For 50 or more, \$25/registered member goes to the network.

This process should provide an excellent incentive for local Networks to recruit new members, increase participation in the national database, and bolster the financial health of their Networks.

- 12. I just want to join the local network, why do I need to list in the IEEE-USA National Directory?
- A: To simplify network operations and make the volunteer offices easier, LAACN and OCCN have opted to use the national directory mechanism as their local directory. This change has made it very easy to display both networks members in a local search from either networks site and provides an automatic method of maintaining a member list and local directory. It also provides an easy way to get immediate listing updates for individual members that are under the individual members control. Of course, being listed in the National Directory substantially extends your exposure.
- 14. I have heard that people have had difficulty with the process. What do I do?
- A: There were some problems that cropped up as a result of fixing other problems. That seems to have all settled out and the renewal process should be smooth now. The magic incantation is the following:
  - Go to http://www.ieeeusa.org/consultants/
  - Select the "Join the Database" link halfway down the page
  - Enter your user name and password using the correct case
  - Select "Renew Listing with Changes" or without changes to update later
  - Update the form with any new or changed information and submit it
  - Verify the returned information and change as needed, then submit it
  - Select whether or not you want a banner ad and continue
  - Fill out short survey
  - Choose Payment Method (Credit card for LAACN Check for OCCN)
  - Complete transaction
- 15. Are there any new fields or changes this year?
- A: Yes. The new fields are:
  - Metro Area Most will select Los Angeles, Riverside or Orange County.
  - Keep Email Private Recommend leaving as no. It removes your email address from your listing making email contact by prospects impossible.
  - Slogan 10 words or 120 characters.
  - Software Tool Expertise Description 200 words or 2000 characters.

The modified fields are:

- Key phrases Increased from 3 words to 5 words or 60 characters.
- Consulting Expertise Description Increased from 50 words to 200 words or 2000 characters.
- 16. Is there a secret to getting a high relevance ranking?
- A: Not really a secret. You need to describe your key capabilities in words prospective clients would use to search. Try to get the key words into the Slogan, Key Phrases, categories, consulting and software tool descriptions, etc.
- 17. Updating the Technical Categories is a bit hard because it is hard to mull over the categories before encountering the large pop up menus of choices.
- A: Do your homework first! Advanced selection of categories is advised as is advanced writing of the slogan, key phrases, and consulting/software tool expertise descriptions. Those can all be pasted into the appropriate form fields during update.

## CHAIRMAN'S NOTES

Several noteworthy developments occurred in July. They are going to produce some improvements and opportunities for members of both the OCCN and LAACN in the next few months.

#### AICN Web Site

The revised Alliance of Independent Consultant Networks (AICN) database is now operational on the IEEE web site. The URL is <u>http://www.ieeeusa.org/consultants</u>. A slightly revised registration process has been initiated. An incentive in the form of rebates to the participating Consultants' Networks is offered. The OCCN needs to revise its registration and renewal procedures to take advantage of these opportunities. The primary advantages provided by the revisions in the AICN database are simplified procedures for sign-up, and for direct modification of the member data by the member himself. The new financial incentives for the CNs provide an opportunity to revise OCCN membership fees downward and/or undertake new OCCN activities for the benefit of members. More information will be provided at our next General Meeting on August 11. The OCCN Board meeting will address the impact of AICN fees and incentives on our member dues structure.

#### AeroWebSpace.com Alliance

In our June meeting with the AeroWebSpace.com Partners, some potential opportunities for collaboration among the AWS, OCCN, and LAACN members and organizations were outlined. In addition to the existing features of this AWS business registry website, a new feature under development is the formation of business development projects called Enterprise Development Groups (or EDGs). Among the potential EDGs mentioned to date are: Communications, Ballistic Missile Defense, Space Launch

Vehicles, and Unmanned Aerial Vehicle Systems. Other suggestions are welcome. We hope to motivate the organization of some EDGs at the next meeting.

In addition to the Enterprise Development Groups for development of business projects by individual OCCN members, we are also considering forming new Special Interest Groups (SIGs) within the CN's. Their purpose would be to exchange information about specific areas among the members. These SIGs would provide a network for exchanging information, thereby enabling our Consultants to upgrade their capabilities in new areas of interest. Much of the SIG activity could be handled by e-mail and OCCN web page communication. Video teleconferencing, home office computer systems, office software applications operating tips, intelligent transportation systems, GPS, and engineering analysis software operating tips have been mentioned as initial possibilities.

Both the EDGs and SIGs will depend on member interest and participation for success. We encourage both members and non-members to join us at our next meeting to help start these activities and influence their direction.

#### **COMSIG Communications Technologies Workshop**

The Communication Society and Signal Processing Society Joint Chapter - Orange County Section (COMSIG) is organizing a fall workshop currently scheduled for Saturday October 6. This workshop will cover recent developments in network communications technologies. Among the topics to be addressed are: configurable DSP technology, network processors, next generation broadband-to-home gateway processors, other network processors and LAN/WAN convergence with the 10 Gigabit ethernet. There will be multiple tracks in this workshop. The program is in the final planning stages. Here is a chance for interested OCCN and LAACN members to spend a day enhancing their knowledge in new cutting edge communications technologies. ## VENTURE CAPITAL: A POSSIBLE SOURCE OF SMALL BUSINESS FUNDING?

Nearly every current or prospective small business owner will eventually feel a need for additional business funding. Whether seeking to expand an already-existing enterprise or trying to get a start-up off the ground, small business owners have traditionally relied on a combination of bank loans and credit extended by their suppliers for these additional funds. But, have these entrepreneurs overlooked a third viable alternative—venture capital firms—to provide the funds they need? Before examining this question in greater detail, let's take a brief look at how venture capital firms, as opposed to banks, evaluate the small businesses seeking their help.

#### **Funding Criteria**

Because banks are creditors, their main concern lies in seeing that the loans they issue are repaid on time and in full. As a result, they usually focus on the recent financial past and immediate financial future of the small business involved and then decide whether its product strength, market share and/or cash flow will be sufficient to repay the requested loan.

Venture capitalists, on the other hand, tend to look much further into a company's future. Their main concerns when so looking include the likelihood of a rapid increase in sales and the anticipated ability to generate a substantial level of profit. Because venture capital firms become part owners in the companies they help fund—by exchanging financial assistance for shares of stock—they tend to be more cautious in their acceptance process than are banks or savings and loans. And, because venture capital firms also invest with an eye toward long-term capital gains (as opposed to interest income) their funding criteria and required rates of return are also generally higher than those demanded by banks.

#### **Prepare Beforehand**

It's hardly surprising to hear that most proposals received by venture capital firms are rejected—often due to incomplete or poor preparation beforehand. As a seeker of venture capital, you should keep in mind that any prospective funder will look thoroughly into your products and services, just as it will investigate your relationships with past and current customers and suppliers. Your operating costs will be examined and an independent auditor will be hired to confirm the overall financial health of your business. Because you are the current owner and possible future "partner" of the venture capital firm, your personal and business backgrounds will also be checked.

If you're a small business owner interested in securing the assistance of a venture capitalist, your first step should be the thorough preparation of a detailed business plan or formal proposal. Key elements in such a plan will include, but not be limited to, the following:

- Purpose of the proposal and dollar amount required
- Product description and company history (if any)
- Current and future marketing plans
- Realistic appraisal of potential difficulties
- Discussion of what makes your business unique.

#### The Quid Pro Quo

Because venture capital firms exchange their capital for an equity interest in the companies that accept their assistance, utilizing venture capital financing can be an expensive proposition for the small business owner. Although the specific terms and percentages of every agreement are sure to differ, a small business with an established operating history or a significant market share will generally be asked to surrender a smaller equity interest than a new or less dominant company.

However, this does not mean that venture capital firms seek to control the businesses in which they invest. Although many venture capitalists will demand representation on a company's governing body, such as the board of directors, they have neither the time nor the resources to exercise day-to-day control over the operations of the many enterprises receiving their help. Moreover, because they are experienced business people, venture capitalists are likely to recognize that small business owners must retain—at least initially—sufficient incentive if these enterprises are to grow.

Among a venture capital firm's more likely requirements is that it be given a voice in formulating any strategic plans that affect the products, marketing efforts or overall financial resources of the company. Some have also been known to require that a merger or sale of a certain percentage of the company's stock take place within a specified period of time. Before agreeing to this sort of venture capital funding agreement, small business owners should be sure they can be comfortable with such an eventual loss of control or seeing their companies go public.

#### Conclusion

Ideally, a venture capital funding agreement strikes a mutually workable and profitable balance between two parties. Applicants, including small business owners, hope that the additional funding will create or increase profits quickly enough to offset any loss of equity. For their part, venture capital firms ask for a rate of investment return sufficient to compensate them for taking on an additional risk.

It's clear that the small business owner who attempts to secure venture capital funding faces significant, but not insurmountable, difficulties. As such an owner, keep in mind that your chances of eventual success are likely to improve whenever you can bring a comprehensive business plan to the negotiating table. And, the more detailed your prospective budgets, pro forma statements and investment analyses are, the better.

## AEROWEBSPACE.COM – How It Can Assist Small Business Growth

At our June meeting, we were introduced to the AWS website concept (<u>www.aerowebspace.com</u>) and it's benefits to consultants and emerging small businesses. AWS was conceived by a group of Aerospace oriented small businesses who had obtained value from the networking provided by the AIAA CALSAT organization. They visualized that a web-based "Business-to-Business" network, containing a directory or registry listing of many small and large businesses, with both similar and complementary missions, would facilitate the ability of these businesses to:

- Market their capabilities to obtain more contracts and work, and,
- Find needed skills and capabilities to fill gaps in their own businesses.

Accordingly, the earliest AWS website featured a directory of small businesses that facilitated finding various high-tech skills and capabilities. Subsequent upgrades added additional functions such as the "Featured Company" column which gave AWS members home page exposure and the capability to advertise and market their firms through publication of their latest accomplishments and news. Other website resources include an Event Calendar, SBIR news, and a host of hotlinks to other valuable websites. Although AWS has an interest in high-tech Aerospace oriented fields, other businesses that can benefit from AWS membership are welcome.

Membership in the Directory presents an affordable means to market your company. For an initial annual fee of only \$50 you can sign up on-line and post data about you and your company in the registry. Potential clients can search the registry database and contact you directly for your services or products. Additionally, members may submit news items on product development, contracts won, project descriptions, white papers, presentation briefings, etc., for free. These news items appear on the AWS Home Page in summary form with a full description on separate pages.

In the last few months AWS has been developing another new feature called *"Enterprise Development Groups"*. The purpose of these EDGs is to bring together small businesses with similar business area interests to facilitate:

- Formation of strategic alliances capture bigger contracts than any single company could do on it's own
- Joint marketing sharing of strategic intelligence, pooling of marketing resources, and exposure to the strategic alliance formed within the EDG
- Networking among EDG members with common interests

Member companies need not divulge their trade secrets, but can organize or collaborate with an EDG to the extent needed to achieve their business goals. The functioning of the EDGs is completely open and may be tailored to the specific business goals, project and management styles of it's members. Each Group will focus on a single business area of current interest. The primary purpose is to market to clients who should be interested in the Group's offerings. The capabilities of the participants under selected current interest areas will be contained on a separate web page on the AeroWebSpace site. The message and market areas will change as often as necessary. Prospective clients are reached through the website, targeted E-Mailings, personal contact, and any other marketing approach deemed appropriate to the particular EDG.

The first EDG being organized will focus on "Communications". Broadband Connectivity, Wireless Optical and RF Last Mile Solutions, and Gigabit Ethernet are likely subtopics under Communications. As the marketing message and subtopics are in the process of being defined, you can influence the selection and content if you subscribe to this service now. The participating individuals will ultimately determine the direction of the Group by contributing to the content, by identifying targets of opportunity, and by making themselves accessible to form ad hoc teams. Teaming will enable individuals to participate in a contracting opportunity that they could not otherwise bid due to size. There is no additional fee for EDG participation beyond the initial \$50 annual registration.

The AWS EDG feature is the subject of the Dr. Wonica's presentation during our August meeting. This will be the second AWS presentation to our membership for the purpose of developing collaboration between OCCN/LAACN and AWS. It is clear that the commercial AWS company can do things for our CN members that are not possible within an organization with non-profit technical society sponsorship, such as the IEEE, AIAA, or ASME.

**Internet FAX Service**– Have you missed faxes because your old-fashioned fax machine ran out of paper, out of ink, or got jammed? Are you tired of paying for a dedicated fax line to get reliable operation, even though you don't get many faxes any more? Well, Internet FAX services have arrived, many at reasonable prices, and may well be what you need.

<u>Www.EFAX.com</u> is my favorite because it gives you the incoming fax mode for free. People send you faxes using your free fax number provided by EFAX. You pick them up as a file attached to an email. I send faxes of documents that exist in my computer directly via my fax modem. If the document needs to be scanned in, I still use the old fax machine to send it. Then I receive all my faxes via EFAX. Because they come by e-mail, I can access faxed documents even when on the road.

EFAX commercials are not oppressive. For a small fee they will handle both incoming and outgoing fax traffic, give you a local fax number (my free number corresponds to an area code in the Spokane, WA area), and imply that they will reduce the commercials. Both Ken Leland and the editor have been quite satisfied with the free EFAX service for the incoming mode. Anybody else use an Internet Fax Service? (Ron Oglevie)

We all hear and read of wireless and mobile technology, of its applications and of its potential for spawning

the next generation of new ventures. Hardly a day passes without an article or news report of a hot new application, which simplifies and enhances our business, home or social life through online data access, online maps, remote electronics control and email-enabled phones. And, of course, we have all read of the wireless and mobile technology rage in Europe and Japan.

But while the technology attracts great interest from the press and early-stage investors, the commercial promise of this technology has yet to materialize. Despite the growing availability of devices and applications, the value of the technology is hindered by software incompatibilities, limited web content and the lack of uniform telephony and computing standards. Moreover, recent reports suggest that several large corporations with highly publicized mobile initiatives are now retreating from their initial objectives.

In this program, the Caltech/MIT Enterprise Forum takes a critical look at wireless and mobile technology and explores the applications where entrepreneurs are likely to find their greatest success:

- Is the U.S. ready for wireless and mobile technology applications?
- Is the application game only for the big device and infrastructure players?
- What applications most interest venture investors?
- Is there a "killer app" for this technology?
- Will voice-to-text technology affect this market?
- Should entrepreneurs wait for more uniform standards?

We answer these questions first with a keynote presentation from Tracy Trent, CEO of Stellcom Inc., a wireless systems integration firm developing applications for Fortune 1000 companies. We then turn to our panel of industry experts and entrepreneurs for their critical appraisal of the keynoter's remarks and their view of the emerging wireless and mobile

Abstract	The wireless Internet offers the notential of access to vital information anywhere at any time.

**Abstract:** The wireless Internet offers the potential of access to vital information anywhere at any time. However, hand-held devices with small screens connected to the web with slow and expensive network connections present new challenges. It is difficult for users of such devices to scan through lists of news stories, restaurant listings, product offerings, or e-mail messages to find personally relevant information. Services that can personalize information for the user based on the user's location, current task, and a profile of the user's interest can make the wireless Internet live up to its potential.

In this talk, consumer and enterprise applications enhanced by personalization are identified. Technology that automatically learns a profile of the user's interest and prioritizes information transmitted to wireless devices or voice portals will be described. Studies showing that the ability to learn preferences and personalize information delivery increases information usage on mobile devices by over 40%.

Michael J. Pazzani is CEO of AdaptiveInfo, a company that builds personalization software for the wireless web that automatically and effortlessly prioritizes information displayed for each individual user. AdaptiveInfo's customers include the Los Angeles Times, Recycler.com and VentureWire. Dr. Pazzani received his Ph.D. in computer science from University of California, Los Angeles and is on leave from Full Professorship at the University of California, Irvine. Dr. Pazzani is the author of 2 books and over 100 technical papers on personalization, data mining and intelligent agents. Dr. Pazzani served as chairman of the Information and Computer Science department at the University of California, Irvine from 1994 to 1999. Prior to coming to UCI, Dr. Pazzani was a group leader at the Artificial Intelligence group of the Mitre Corporation in Bedford, Mass. He has served on the board of directors for CombiChem and advisory boards for numerous companies including Pharsight, Stock100, Triplehop Technologies and NetGUI.

## CHAIRMAN'S NOTES -

## PROGRAM DEVELOPMENT COMMITTEE STATUS

During the last LAACN/OCCN Joint Meeting, the status of the Program Development Committee's efforts were reviewed. To date, about a dozen suggestions for programs have been identified as "worthy" of further development. To be considered "worthy" at this point in time, a suggested program should have robust interest among members of the program committee and an identified "sponsor" who could serve as organizer to "make a successful event happen". We hope to expand the participation in this program development process from the program committee to the members of LAACN & OCCN. We hope to identify and produce many other "worthy "programs.

The suggested programs meeting the above worthiness criteria for further development are:

- 1. A Computer/Internet-Aided Teleconferencing Workshop (involving several speakers covering both the available technologies and some sort of "training" program to enable our consultants to perform remote teleconferencing with clients and business prospects).
- 2. Building a "Virtual" Company.
- 3. How Do the Most Creative Innovators Think?
- 4. Developing Your Own Web Site.
- 5. How I Do My Consulting Business (involving short presentations by LAACN/ OCCN members at each General Meeting).
- 6. Recent Developments in GPS Applications & Technology.
- 7. Occasional Purely Social Gatherings Involving Spouses and Family (barbeques, picnics, outings tours, etc.).
- 8. Developing Strategic Alliances.
- 9. Marketing for Engineers and Consultants
- 10. Off-Shore Consulting: Considerations for Consultants Involved in Projects in Foreign Countries.
- 11. Joint Meetings with Other Technical and Business Professional Organizations (such as AIAA, ION, ASME, and IEEE Professional Groups, etc.).

New programs from this list are in the process of being planned and organized. We welcome comments and suggestions on topics and arrangements for programs. Two programs have resulted from this planning process to date. The first was a presentation by Michael Morehouse at the April 14 Joint Meeting of the LAACN & OCCN. The subject was ISO-9000/-9001:2000 - How a Small Consulting Firm Can Meet the Training Requirements. This presentation showed how the ISO-9000 requirements affect different fields in which consultants work and how the certification requirements can be met. Our thanks to Mike Morehouse and organizer Ralph Hileman for a job well done.

The second is a program also being constructed by Ralph Hileman on Bid Decisions. It is scheduled for our next meeting on May 12<sup>th</sup>. It should also prove valuable to consultants and others in many fields of technology. Please attend and encourage others to participate.

Other programs will follow in the future. Ron Oglevie and other members of the Program Committee deserve kudos for their work to date.

Are you seeing any impact from the dot.com cutbacks, particularly those in Silicon Valley? I had expected several companies, including Intel, to cut back on their spending – but they came through with a contract. It is bound to have an effect soon. Has it hurt you? What should we do?

I just received news from AICN, the national network of consultant networks, that a new group is being formed in Harrisburg, PA. More members make a more impressive directory.

The AICN also asks if we know any companies that have videoconferencing facilities and would be willing to let AICN/IEEE use them for committee meetings. I would also be interested in exploring the possibility of LAACN meeting on-line as a true virtual network.

### **RECENT DEVELOPMENTS** by Pete Schultz, OCCN Chairman

On February 26<sup>th</sup> a meeting sponsored jointly by the IEEE Orange County Computer Society (OCCS) and the OCCN was held at the Wyndham Gardens Hotel in Costa Mesa. This was the first attempt by the OCCN to improve our programs through collaboration with other technical organizations. The subject of the program was the new Microsoft.NET initiative. Todd M. Rowe of the Southern California Microsoft Corp. office in Irvine gave the presentation. In 1.5 hours of a presentation and 0.5 hours of discussion, this event managed to provide something for all in an audience with a variety of interests. The interests of the audience ranged from marketing and business development through information technology professionals to software developers and programmers. The collaboration and program proved to be successful and we will be attempting further join programs in the future.

The Microsoft.NET program developed sufficient interest among our members that a portion of the March General Meeting was devoted to an extended presentation and discussion moderated by Pete Schultz.

### **NEWS ITEM –**

## LAACN/OCCN Alliance Operating Arrangements Defined

The operating arrangements of the new alliance between the Los Angeles Area and Orange County Consultants' Networks were defined at the January meeting and extended at the February meeting. The basic framework is now in place but should be regarded as the point-of-departure for future improvements. The goals of the alliance are:

- Simplified Operations for Mutual Benefit Advantages are a larger combined membership, and a reduction in the effort required organizing two separate programs.
- Retention of Separate Identities For the both organizations.

The following activities were selected for joint collaboration, both in the organization and conduct of activities, to the extent limited by practical considerations:

- Joint Meetings, Workshops, and Clinics –
- Joint Newsletters, Mailing Lists, Marketing and Publicity –
- Listing in AICN Directory Member listing in the Alliance of IEEE Consultants' Networks Directory to be continued and done jointly.
- Website Collaboration Websites to retain separate identity. Each will at least perform the functional equivalent of listing the other's member profiles. AICN Website linking may provide this data. OCCN will link with the LAACN site to provide joint Bulletin Board discussion functions.
- Referral Processing John McCrickerd (OCCN) and Russ Walker (LAACN) to collaborate on requests for referrals.
- Needs and Leads John McCrickerd to distribute them to both networks.

The areas not being treated jointly include:

- Separate Network Identities –
- Officers and Elections –
- Individual Websites With the shared Website features given above.
- Treasuries, Bank Accounts, and Financial Matters Financially independent.

The joint alliance will be maintained until at least January, 2002, and then re-evaluated as needed. Initially, meetings will be held at the Cal State Fullerton Engineering Building site. The need for a Los Angeles area meeting site, preferable locations, and meeting schedules (such as alternating meetings between LA and OC) are being discussed with the LAACN members by their new Chairman, Mr. Bob Gauger. Dr. Kip Haggerty is credited with proposing the collaboration, and then making the effort to bring it to reality.

At this time, most of the actions required to implement the above alliance agreement items have already been taken and joint operations are being conducted. Improvements are to be expected with operating experience and as more people become involved. Members who would like to suggest improvements are requested to call or email your ' 2001 Network Chairman.

## OCCN CHAIRMAN'S NOTES –

Last month's Microsoft dot NET presentation was well attended and brought out significant interest and questions. Accordingly, we will devote a portion of our next General Meeting to review and discuss the implications of the concept, with emphasis on what it might mean to consultants and small businesses. For those who weren't able to attend, additional information on the dot NET concept is available on <a href="https://www.microsoft.com/net">www.microsoft.com/net</a>. This will be a discussion group so do your homework and bring your questions.

Other priority issues for the Network are defining our future activities and marketing efforts. The remainder of the General Meeting will focus on these issues.

# OCCN WEBSITE – Increasing Member Value (www.occn.org)

Since the beginning of our Consultants' Networks almost a decade ago, member interest continues to shift. The public networking meetings of the past seem to be giving way to more virtual operation featuring the Internet. In fact, many of our members now join solely for the exposure provided by our Website listings. Accordingly, your CN officers continue to shift their emphasis toward providing quality Websites of increasing value to the members.

Several months ago, an ad hoc committee consisting of your OCCN Webmaster - Ken Leland, Ralph Hileman, Ron Taggart and Alan Lui met to outline changes to improve the "look and feel" of the site, and to bring it into accord with current web page style standards. Accordingly, the webmaster performed a redesign and the new version of the site was completed before year-end. We expect continuing changes to improve the effectiveness and value of the Website for our members.

On the OCCN Website, the "Member Profiles" section had previously been hosted for several years on the Webmaster's personal server, because the Verio company did not provide Microsoft friendly hosting. The problems associated with this approach have now been resolved. The old "Profiles" section has been replaced by the joint OCCN/LAACN search engine. This search engine was originally developed by Ms. Leslie Haggerty of the LAACN and first used on the LAACN Website. Subsequently the same search engine was adopted by the AICN, and now by the OCCN. Queries initiated on the OCCN Website are now sent to the AICN site, with the replies posted back on the OCCN site. The search is automatically limited to LAACN and OCCN members. Of course one could go directly to the AICN site, but this approach is easier for people to find consultants located in Southern California. All Website modifications for joint LAACN/OCCN operation are now functioning.
