

ExCom Meeting Minutes – March 2007

Summary of meeting held 7 March at Cogswell College in Sunnyvale, CA.

Attendance: 24 – (see attached attendance list)

Section Vice Chair Ram Sivaraman called the meeting to Order at 6:05 pm.

Agenda

1. Approval of the Agenda for this meeting:

The Agenda was revised to discussion of two upcoming CAS Chapter events and a presentation on the Chapter Formation and Development Committee by Paul Wesling. Having no further action to amend or modify, the Agenda was approved as revised.

2. Approval of the Meeting Minutes for February 2007:

Having no action to amend or modify, the Minutes for the February 2007 ExCom meeting were approved as submitted.

3. Chapter Reports This Meeting:

Ram reported that Section Secretary, Allen Earman, was not able to get in touch with the Santa Clara University Student Chapter and UC, Santa Cruz was not on the original list for March. So, neither of these student chapters will present. Ram also noted that the Power Electronics Chapter would be discussed later in the meeting.

Will Lumpkins noted that he attended a meeting at the San Jose State Student Chapter and remarked that they would be presenting at the April ExCom meeting and that they were unaware they were to present. Allen Earman noted that he has been sending out reminders approximately one week in advance of the ExCom meetings. No notice has been yet sent to the chapters presenting in April other than the original schedule sent by Tom Coughlin at the beginning of the year.

Fred Jones reported that he was not ready to present for PE/IAS Chapter. So, this presentation will be postponed until the next meeting in April.

Richard Lira presented the Chapter Report for the Microwave Theory & Techniques Chapter. Richard reported that this is the Fifty-first year for the SCV MTT Chapter. The current membership is 581. The Chapter held 8 meetings in 2006 and have planned 7 meetings for 2007. The meetings are held at Intel. Typical meeting attendance is 35 – 110 attendees. The chapter is planning a short-course for 5 May at the Stanford Linear Accelerator. The current Chapter Bank Balance is \$6501.59. Richard also presented the detailed plan and budget for the May Short-Course.

It was MOVED by Lee Colby, SECONDED by Ken Doniger to approve the May Short-Course planned by the MTT Chapter. Dan Oprica noted that the MTT Chapter is oldest chapter in SCV and also has the highest ratio of Senior Members. The MOTION was Approved unanimously.

Will Lumpkins questioned the need for the Section to approve events held by SCV Chapters. It was explained that if a chapter were to lose more money running an event than they have in their bank balance, the Section would be liable for the payment of funds. Will commented that he had recently attended an IEEE leadership conference

and that there are no regulations specifying that a section must approve chapter events if the chapter is not asking the section for financial support.

Ken Doniger presented the Chapter Report for the Engineering in Medicine and Biology Chapter. Ken reported that the EMBS Chapter currently has a Bank Balance of \$8000 and held 9 meetings in 2006, all at Stanford University. The Chapter is planning to hold 9 meetings again in 2007. Paul Wesling commented that there is a lot of work going on in the area of Computational Bio-Infomatics. He asked whether this belonged in the area of EMBS or another chapter. Ken said he would look into the subject. Ken noted that the Chapter typically has about 30 – 40 attendees at each meeting. Paul noted that another EMBS Chapter is forming in the San Francisco Section.

Dan Oprica asked if there was a new Section Contact List. Allen noted that he had compiled the list and that Paul had already published it in the eGRID. However, Allen noted that he did not have all the contacts for the student chapters and has not been able to get accurate, up-to-date lists of student chapter officers.

Howard Sun from the CAS Chapter described the upcoming events the Chapter is planning. One is a Seminar to be held on 19 May at Cadence.

It was MOVED by Ken, SECONDED by Allen to approve the CAS Chapter event. The MOTION was approved unanimously.

The other is a Tutorial featuring an IEEE Distinguished Lecturer. The Chapter will need to cover the lodging, auto, and meals expense for the Lecturer. CAS has estimated this expense at \$500. Howard asked that the Section support part of this expense - \$300. Will Lumpkins commented that he is the Distinguished Lecturer Coordinator for CAS Society and that the Society only sets a limit on the total travel cost, not how it is spent. Howard stated that the Society had told him that it would only cover the travel expense and not local expenses as described above.

It was MOVED by Roxsana Hadjizadeh, SECONDED by Fred Jones, to approve the CAS event and provide the requested amount of \$300 for local expenses for the Distinguished Lecturer. There was much discussion on how the funds should be provided to the CAS Chapter. Some members suggested that the funds only be provided in the case that the Chapter lost money on the event. Others suggested that the Chapter borrow the funds, to be repaid if the Chapter did not lose money. Ram suggested that since it was only \$300, the Section could provide the funds as a Grant to the Chapter. Will Lumpkins commented that he just looked on the CAS Society Webpage it only stated a total limit for Lecturer travel expenses and asked Howard to forward him the confirmation e-mail from the Society stating that only the airfare would be covered. Paul noted that different societies cover different expenses. Fred noted that PE Society only covered airfare. Dan Oprica noted that SSC Society covered everything except transportation expense to/from airport.

The MOTION was Approved unanimously.

4. Acting Chair Report (Ram):

1) Chapter Formation and Development Committee:

Paul Wesling presented his proposal (attached) for the structure and tasks for the committee. Each year, the Section Chair would check to see if the committee was operating in good manner. If not, the Section Chair would ask the outgoing Section Chair to take over as Committee Chair. Paul proposed that committee have a budget of a couple of thousand dollars. If the committee goes well for several years, then the Section could update the Bylaws and make the committee a Standing Committee of the

Section. If the Section saw no further need for the committee, then it would simply cease operations. Some of the near-term tasks would include a Mentoring programs for experienced chapter officers to work with new chapters. There are several current chapters that could use support and the committee would get involved to help these chapters. Longer-term, the committee could establish Best Chapter Awards and possibly a few others. The committee also could establish a "Best Practices" set of guidelines. The committee also could support IEEE membership development in the SCV.

John McBain commented that the committee should have a set of approved and understood goals. Rich Lira asked regarding the criteria to start a new chapter – such as the number of people interested in starting a chapter. Dan Oprica commented that he thought focus should be on combining struggling chapters with healthy chapters. There are several chapters struggling for survival. He further noted that it is better to have a few meetings with good attendance than to have meetings with only a few attendees. Paul noted that this is not the view of the Committee described in his proposal. Allen commented that he agreed with Dan in that there are so many chapters currently competing for attendees. He also noted that several chapters have all but ceased operations. Should these be revived even if there is little current interest in them? Thirdly, he noted that with the number of troubled chapters, this could require very much effort on the part of the committee to assist these chapters. Paul claimed that the apparent lack of interest is really lack of leadership. Paul also noted that too meetings is not a problem as the subject interests do not overlap. John commented that new chapters and new officers would need to learn the basics of starting or building a chapter such as how to start a Webpage. Will Lumpkins noted that in other Sections set aside funds for chapter development and hold leadership training for new officers. Will also noted that the Region has funds for Chapter development. Allen noted that we have been offering the New Officer Training every January for several years. Dan noted that other chapters should exist in the area that do not. Jonathan David noted that there are some areas of technology in the area that are not covered by existing IEEE Societies. Perhaps we should be looking at these. Howard suggested that we should consider having New Officer Training more than once a year. Ken Doniger commented that this is large scope proposed for the committee. We should choose a piece that we can manage at present. He also supported the idea of combining some chapters. John also noted that if the chapters are combined and they develop well, they can be split off at some point in the future. Allen also noted that the past chair for the Antennas & Propagation Chapter stated that he could not find members who wanted to be officers and therefore, they did not hold chapter elections at the end of 2006. Ram suggested that the committee meet with people from the troubled chapters to find out the issues they are facing.

It was MOVED by John McBain, SECONDED by Roxsana, that the Committee be formed with a small budget, move forward with established goals and report back at the next ExCom meeting. Ram volunteered to Chair the Committee. Acting Chair Ram Sivaraman appointed the committee: Ram Sivaraman, John McBain, David Craven, Ken Doniger, Marcelo Siero, Allen Earman. The MOTION was Approved unanimously.

2) Interactions with Other Groups:

Paul Wesling described the Summer Engineering Technology Program for Junior High Students. This is put on every year during the summer. This year it will at three locations. It is funded by grants – they do not need funds from the Section. This seems like a natural fit for our K-12 effort. This program is run by Jay Pinson. Lee noted that

these students are selected by their math and science teachers. Paul noted that if we sponsor this, we will be listed as sponsor on the promotional material. Allen noted that there was an action from last month for Lee to provide an update. Will stated that we will need a MOU to support this. Lee provided the update information regarding the number of sessions and topics – a very comprehensive list. Lee suggested that we support this and provide several volunteers to talk at the sessions.

Jonathan MOVED, SECONDED by Ken, that we approve the co-sponsorship and get an MOU to review at the next ExCom meeting. Will noted that the MOU does not require full section vote if no money is involved – the Section Chair can approve. The MOTION was Approved unanimously.

3) SVTI Educational Courses Relationship:

Kris Verma described the proposed SCV Section-Silicon Valley Technical Institute relationship. Kris described the SVTI and its mission with a short presentation. Kris proposed that IEEE promote the SVTI schedule and would receive compensation based on attendees. Kris noted that many of these seminars have been presented many times previously. Paul commented that he had asked SVTI to advertise in the eGRID. The Section could vet the courses.

Will Lumpkins questioned the IEEE regulations regarding cooperation with a for-profit organization, but expressed his support if IEEE agrees. Roger Hoyt expressed concern about putting the IEEE name on these courses. Kris reminded the ExCom that this requires no funding by the Section. Roger commented that he saw no problem with SVTI advertising in the GRID, but that the oversight of the course materials and instructors by IEEE could become quite involved. Jonathan noted that we had a similar relationship with Stanford awhile back so that IEEE members could receive a discount on short-courses.

The discussion was tabled until the next ExCom pending Will receiving a response from IEEE Legal.

Dan Donahoe, CPMT Chair, presented the detailed plan and budget for the 33rd IEMT/APM (International Electronics Manufacturing Technology/Advanced Packaging Materials) conference the Chapter is sponsoring in Fall 2007. This conference will 50% jointly sponsored by the CPMT Society with the Chapter. They expect 150 – 250 attendees. Total receipts expected are \$90,500, costs of \$76,565, leaving ~\$14,000 surplus. Will Lumpkins asked if this was arranged with another group and if an MOU was in place. Dan explained that this is a joint event with the parent CPMT Society and that the MOU currently is being reviewed by the Society. Paul noted that CPMT Society has already approved the Hotel Contract.

It was MOVED by Ken, SECONDED by Richard Lira, that the CPMT sponsorship for IEMT/APM be approved. Will further asked who owned the copyright for the conference and Dan explained that it was owned by the CPMT Society. The MOTION was Approved unanimously.

4) Event Registration Services:

Paul reviewed his summary of the Event Registration systems available. PayPal is commonly used. Cvent does not publish their rates on their webpage. SVEC used Brown Paper Tickets for the Engineers Week Banquet. There also is IEEE Conference Services – operated by IEEE. (See the attached summary.) The IEEE service is competitive in pricing, but does not provide immediate notification of bounced charges. Also, payment is made into the chapter's Concentration Banking Account.

Paul recommends that each chapter evaluate their needs and select the service that best fits these needs – may also vary depending on the type of event: meeting, seminar, conference, etc.

Allen asked if the summary included options for IEEE member discount pricing and post-event attendee lists. Paul noted that all allowed multiple price structures and also that all of these services can provide the attendee lists.

Paul noted that some of these are difficult to set up. He would be willing to show people how to set these up, or could do it for you and charge your chapter.

5) SFBAC Banquet:

Fred reminded the ExCom that the SFBAC Banquet would be held at the San Mateo Marriott on 31 March 2007. Currently there are 125 sign-ups. Space is available for 150. Paul has extra application forms if someone wants to sign up.

David Saperstein addressed the ExCom and stated that he would have to step down as Section Webmaster due to competing requirements for his time. He will be available to assist the new Webmaster to get up to speed on the details. The Section needs to find a replacement as soon as possible. Ram noted that we would be willing to pay an honorarium to the new Webmaster.

Fred asked Allen to resend the Chapter Health Scorecard to the ExCom. Allen stated he would like to update it with new information before sending it out.

6) Science Fairs:

Ken Doniger reported that there are two upcoming Science Fairs in March – one on the 14th and one on the 17th. Traditionally, we award three \$50 prizes in each. Ken needs to collect the checks for these. Anyone who wishes to attend should talk with Ken. Ken noted that at the Santa Clara Fair, IEEE would not be the regular judges, but Special Judges, since we will be awarding our own prizes.

John McBain noted that the Product Safety Engineering Chapter has for a number of years been sponsoring their own Science Fair prizes and do so again this year. Also, PSE has increased the dollar amount of the prizes this year.

7) Charles Lord Zigbee Tutorial:

Charles Lord was asked if he could move the date for his tutorial in the Bay Area. He got back saying that he would prefer to keep the original date.

8) Ralph Wyndrum Petition:

Ram reported that Ralph Wyndrum had sent out a petition for running for IEEE President Elect and Ram will circulate this through e-mail.

5. Vice-Chair Report (Ram):

Ram reported that ALL chapters had submitted their L-50 information to him and the Section L-50 report was submitted complete. Ram said he still needs to send to the Hardcopies to IEEE. Allen asked that Ram send him the updated year-end chapter balances for the Chapter Health Scorecard revision.

Ram also report that he an Roxsana are working on the one-year extension of the Section budget so the budget will extend through the year 2008 to prevent last minute rushing to generate a budget for the current year.

Ram further noted that every time we submit the L-50 we are supposed to submit a budget and we have not done this since we did not have a budget at the time of L-50 submission.

6. Secretary's Report (Allen):

Allen asked if everyone had signed the attendee list for the meeting and if anyone else wanted to sign the sympathy card for the Family of Joe Roybal.

7. Treasurer Report (Roxsana):

No additional report.

8. Committee Reports:

- SVEC Representative – Dan Oprica.
 - Dan thanked Fred Jones for all the support he provided and thanked the Section for the Scholarship donation this year. Dan noted that IEEE always seems to get tables at the edge, not in the middle. Dan suggested that next year the Section become a sponsor of SVEC at the lowest level.
 - Ken reported that he ran into Carolyn Koenig and she was surprised that she was no longer the IEEE SVEC representative. Fred noted that he had seen her only at one of the meetings last year.
- GRID Editor – Paul Wesling – No report.
- PACE Chair – Jonathan David – Jonathan reported the PACE meeting the previous night. PACE meeting in April will be on getting your voice heard in Washington DC. One chapter has signed up to work with PACE on the Profession Development Workshop for 13th October. Jonathan is still looking for other chapters to contribute tracks for the workshop.
- GOLD Chair – Not present.
- Nominations and Awards Chair – Dan Oprica
 - Dan reported that he will propose Altera for the Company of the Year award again this year. Dan made 3 nominations last year, but only one was accepted. Region 6 changed the criteria after Dan had submitted his nominations.
 - Jonathan David nominated Cadence for the Friend of IEEE Award. Dan will send the form to Jonathan.
- Finance Chair – Roxsana Hadjizadeh – No report.
- SAC Chair – David Craven
 - Tim O'Konski reported that he and David have been working on the Student Chapter status. They have talked with San Jose State and Stanford so far. They are interested in the Section helping with their membership. Tim also noted that they have contacted a faculty member at Santa Clara Univ.
 - Will Lumpkins reported that he is involved with the CE society going to universities to solicit interest in starting a CE student chapter. He also found that Cogswell College is interested in starting an IEEE student chapter and he is working on that.
- Program Chair – Ram Sivaraman – No report.
- Membership Chair – Slava Mach
 - Slava reported that this Saturday there will be the next Member Development Webinar. However, it will begin at 10AM EST – or, 7AM PST.
- Educational Activities Chair – Will Lumpkins
 - Will reported that he is working on the Make-Fair with Stanford Univ. for the CE Society. He has an MOU in place. If the Section would like to be involved, they can have someone in the CE sponsored booth.

- K-12 – Lee Colby – No report.
- Webmaster – David Saperstein – No report.
- Senior Member Advancement – Mark Hooper
 - Mark would like to nominate Dr. Mark Lachman for Senior Member.
 - Another member contacted SCV on his own. The committee does not think he is yet qualified for Senior membership.
 - IF we agree that others on the list are eligible, then he will contact them and follow up on the applications.
- IEEE Engineering Milestone Coordinator – Dick Ahrons – No report.
- Audit Committee – Slava Mach – No report.

9. Other Business:

- Dan Oprica reported that the SSC Chapter 10th Anniversary .party will be held 22 March.

The Meeting was ADJOURNED at 8:39 pm.

Rather expensive:

\$35 reg'n cost: 3.5% up to \$1 = \$1.23; plus 2.5% for MC/Visa = \$0.75; so total is **\$1.97, or 5.6%**. (more, for AmEx)

\$100 reg'n cost: $\$1.50 + 2\% = \$1.50 + \$2.00 = \3.50 ; for MC/VISA = \$2.50, so total is **\$6, or 6%** (more, for AmEx)

PayPal and Excel

Cheapest, but most work for volunteer:

\$35 reg'n cost: $2.9\% + \$0.30 = \$1.01 + .30 = \$1.31$ plus 0% for MC/VISA/AmEx, so total is **\$1.31, or 3.7%**

\$100 reg'n cost: $2.9\% + \$0.30 = \$2.90 + .30 = \$3.20$ plus 0% for MC/VISA/AmEx, so total is **\$3.20, or 3.2%**

(Chapter needs a separate checking account)

EventBrite

Moderate; **can have pay-at-door**, but that's expensive:

\$35 reg'n cost: $2.5\% (.99 \text{ min}) = \$0.88 \text{ or } \$0.99 = \0.99 plus 2.5% + \$.30 for MC/VISA/AmEx = $\$0.88 + .30 = \1.08 , so total is $\$0.99 + \$1.08 = \mathbf{\$2.07, \text{ or } 5.9\%}$ (pay-at-door: \$0.99, or 2.8%)

\$100 reg'n cost: **no charge for "pay at door/send check"**; $2.5\% + \$1.00 \text{ for MC/VISA} = \$2.50 + 1.00 = \$3.50$, so total is **\$3.50 (3.5%)**; $3.5\% + \$1 \text{ for AmEx} = \$3.50 + \$1 = \4.50 , so total is **\$5.50 (5.5%)**

Section pays \$200/year to cover the service; we have it through 2007.

(Check is mailed; Chapter doesn't need separate checking acct, can use Concentration Banking)

BrownPaperTicket

Inexpensive, but must use VISA/MC/AmEx (**no pay-at-door option**):

\$35 reg'n cost: $2.5\% + .99 = \$0.88 + \$0.99 = \$1.87$ (for MC/VISA/AmEx); so total is **\$1.87, or 5.3%** (no option for pay-at-door – need to handle these separately)

\$100 reg'n cost: $2.5\% + \$0.99 = \$2.50 + 0.99 = \$3.49$ (for MC/VISA/AmEx);, so total is **\$3.49, or 3.5%** (no option for pay-at-door – need to handle these separately)

(Check is mailed; Chapter doesn't need separate checking acct, can use Concentration Banking)

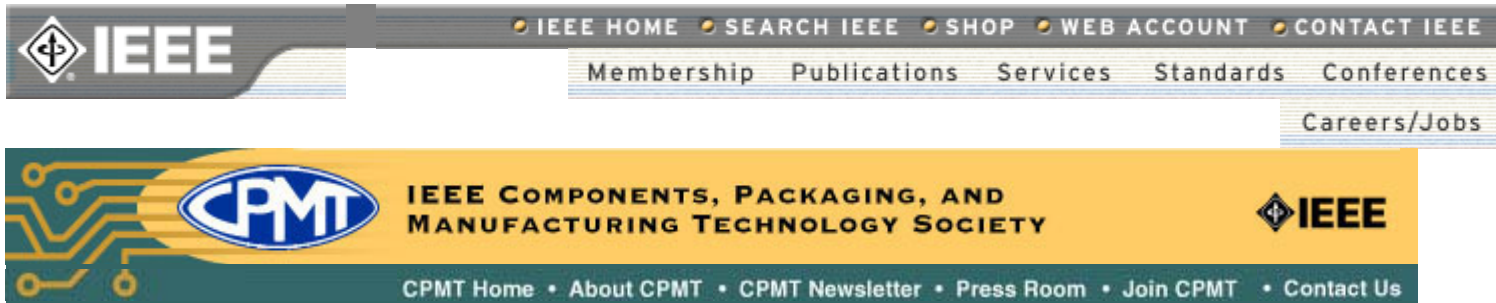
