IEEE Region 3 Area 6 Report – Ron Ogan rtogan@ieee.org

On April 5, I attended the Alabama Section meeting at Birmingham meeting in Hoover, AL which is 124 miles south of Huntsville. The meeting had about 35 attendees and was on Radio Frequency Identification (RFID) presented by Subramanian Nambi, Atlas RFID. No Region 3 funds were used.

Last Wednesday 4/28 and Thursday 4/29/10, I attended the 2010 Science, Engineering and Technology Congressional Visit Day in Washington DC as arranged by IEEE-USA. The training included briefings on Research & Development that was held at the American Association for the Advancement of Science <u>www.aaas.org</u> Check the AAAS website for career development information, trends on R& D funding (<u>http://www.aaas.org/spp/rd/)</u> and other interesting topics on STEM cells and climate.

No Region 3 funds were used for the CVD meeting.

I visited congressmen in Mississippi where I worked for Raytheon last year Met with staff of MS Senators Thad Cochran and Roger Wicker staff Met personally with MS Congressman Gregg Harper

I visited congressman where I work GTRI in Huntsville, Alabama Met personally with AL Congressman Parker Griffith, M.D., 5th District Met with staff of AL Congressman Robert Aderholt, 4th District

IEEE-USA provided position statements, brochures and "leave-behind" packets for the Congressional staff contacts. The U.S. legislative issues that I discussed were America COMPETES which reauthorizes R& D funding for NSF, DOE, NIST and DoD agencies. The four year R& D authorization initially made in 2007 was for \$43B. I also, discussed, the U.S. Patent Reform act changes from "first to discover" to "first to file" to avoid lengthy litigation and delays in getting patents issued to make the process more efficient. He is strongly against this idea and would like to see America go back to the moon and not have to depend upon Russian rockets for space travel after the Space Shuttle vehicles are retired later this year.

Congress introduced the Patent Reform Act, S. 515 and H.R. 1260, in mid-2009. The bill sat quietly from March 2009 to March 2010, when Senate leaders announced that they wanted to pass the bill quickly. IEEE-USA now expects the bill to be voted on in the Senate within a month, followed by consideration in the House of Representatives.
