### ExCom Meeting

Director Stogner welcomed the ExCom members to the e-conference at 9:04 PM EST and thanked them for their participation. Director Stogner reviewed the plans for the evening. The group used IEEE's Dimdim Web Meeting service along with its conferencing bridge service with Skype, toll-free 1-888, and long distance dialing along with Web pages to accomplish its work.

David Green requested that an item be added to the agenda concerning the Region 3 On-Line Community. The ammended agenda was reviewed and adopted including the consent agenda:

### Action Agenda

Southeastcon 2009: Don Hill stated that there was still no final report for Southeastcon 2009.

Operations Manual: The ExCom voted to endorse the R3 Operations Manual, revision 15 July 2010, with no opposition. Much appreciation goes to Dick Riddle for his effort in revising the document.

### Discussion Agenda

Employment Assistance Project: Ed Kirchner gave an update on the Employment assistance proposal. It has been approved by committee and is expected to be approved by the IEEE Board. He stated that a "Train-the-Trainer" workshop would occupy all of the schedule for Saturday of the Fall Region 3 Committee Meeting.

Fall Region 3 Committee Meeting: Director Stogner presented information about the Fall Region 3 Committee meeting in Atlanta. The contract with the Atlanta Hilton Airport Hotel will be signed this week. It is anticipated that 60 members will attend from all over the Region.

Membership development status and discussion: Jim Anderson reported that that IEEE is doing

quite well over all with membership this year. Region 3 has retained about 97% of its members so far.

Employment Picture: George McClure was not present to give an employment report for Region 3.

On-Line Community: David Green presented information about a migration of the Region 3 On-Line Community to a new service.

New Business: Eric Ackerman presented the idea of having a Student Employment Training session at the Hilton on Sunday afternoon for local Atlanta area students. [However, the hotel contract does not list any meeting rooms for Sunday afternoon. (Note from Gregg Vaughn 8/16/10)]
