Committee is considering continuation of this program into 2013 and is interested in feedback from Sections about what changes would cause greater participation; send email to montague@ieee.org. If continued the program would be limited to use of the remaining portion of the \$20,000 budgeted for 2012 after Sections qualifying in 2012 have grants paid (about \$15K).

The first weekend in August is the date for the IEEE-USA 2013 Annual Meeting and PACE leadership training. Region 3 subsidies for Section PACE Delegates come from funds provided by the IEEE-USA PACE committee which has directed that first time attendees be given preference for these funds. Additional guidance is expected from the committee as to how much discretion individual Regions are allowed in apportioning funds between first time attendees and prior attendees. Sections should include in their 2013 budgets funds to fully support their PACE Chair's travel to the IEEE-USA 2013 Annual Meeting if they have attended prior events. A Section PACE committee should not be a "committee of one" and the appointment of a PACE Vice Chair is encouraged – a first time attendee Vice Chair may be given priority for PACE Delegate travel funds over PACE Chairs who are prior attendees.

2013 Budget time is at hand. Sections should plan for at least four PACE events in 2013, at least one of which should be more significant than a unit meeting, i.e., a Professional Awareness Seminar (formerly M-PAC) or an Engineering Week series of events. When budgeting for these activities keep in mind that the guidelines for Region funding assistance is that Region funding be no more than the Section's funding (excluding other sources of event funding), normally with a maximum of \$500 although exceptions are readily available if significant numbers of members are served. Also consider budgeting for other Professional Activities like support for a member who will participate in the Congressional Visit Day program.

Requests for 2012 Region support of Professional Activities Projects is about \$2K less than the amount that IEEE-USA will reimburse the Region. Final reports for all 2012 Professional Activities Projects approved for Region 3 funding are due no later than Sunday December 16 – this is a hard deadline unless a written extension has been obtained. This report must show total actual expenditures for the project and income by funding source (non IEEE entities, participant fees, Section funds, Region funds, etc.). Final Region payment to the Section will be made based on this report. Sections are invited to submit a similar report for each additional Professional Activity that has received Section funding. Based on all reports received, Sections will be reimbursed for some of their expenditures on a pro-rata basis until all the IEEE-USA reimbursement allocation has been used.
