Attached is the Region 3 MELCC report to the July ExCom. I am also including the Senior Member Application July 14th status spreadsheet and 2016 Region 3 Meeting Details Report.

Please note the following:

- The 2016 Region 3 Goal is 250 Senior Member elevations.
- 119 Senior Member elevations as of the June panel – We have a long way to go and **only 2 more panels this year.**
- Total of 57 applications in the pipeline
 - 8 applications should be reviewed in the July panel on July 23rd
 - 49 pending applications needing references (see the list below)
 - 131 (52%) more Senior Member elevations are needed to reach the Region 3 goal. Even if the 57 applications are approved we are short of the goal by 74 elevations.
- Panel targets are: Jul 10, **Sep 50 & Nov 71**. That means that **by August 26th (in a little over a month)** we need to complete at least 60 applications.
- The **deadline for the Hong Kong panel is Friday, August 26th.**
