Attached is the Region 3 MELCC report for September 19th. I am also including the Senior Member Application September 16th status.

The MELCC has kicked off a Senior Membership elevation effort to assist the Areas and Sections with the process of identifying potential members and building a Region wide list of potential references. I would like to thank Mauricio Cano for suggesting the idea and for his hard work in getting this started. Most of you will have seen an email from Mauricio to identify members who can assist with the process as an application reference. We have had a strong response so we will soon begin the next step of sending emails to members who might be eligible for Senior Membership based on number of years since graduation. I strongly encourage those officers of each Section who are Senior Members or Fellows to respond to Mauricio's email with your support of the effort and your willingness to be a reference.

Thank you in advance for your assistance.

Please note the following:

- The 2016 Region 3 Goal is 250 Senior Member elevations.
- 127 Senior Member elevations as of the July panel (51% of our 2016 Goal). We only had 8 applications approved in the July panel. We have a long way to go and **only 1 more panel this year**. Results from the September 10th panel have not been reported.
- Total of 94 applications in the pipeline
 - 47 completed applications some of which were reviewed in the September panel on September 10th
 - 47 pending applications needing references (see the list below)
 - 123 (49% of our goal) more Senior Member elevations are needed to reach the Region 3 goal. Even if all 94 of the applications in the pipeline are approved we are short of the goal by 29 elevations.
- Panel target for **Nov is 90**.
- **The deadline for the New Brunswick panel is Wednesday, November 9th**.
