- V. Action Agenda
 - a. Fall SoutheastCon Technical Papers (October 2018) – Jim proposed the concept as a way to pull in more students. Could expect to have 50 to 75 paper submittals, approximately 100 attendees, and relatively low cost (hold at a university). The following concerns/questions were raised:
 - i. Eric G – Concerned about the revenue impacts to spring SECONs, bulk of revenue comes from paper submittals.
 - ii. Mary Ellen – How could we break out papers evenly between spring and fall SECONs?
 - iii. Jim – Suggested that review past registrations for SECON to verify the number of paper registrants
 - iv. David G. – Any thought to how would fold in practitioners?
 - v. Chase – Noted that most practitioners are more interested in obtaining professional development hours (PDHs) or continuing education units (CEUs) for meeting Professional Engineer license requirements.
 - vi. Jim – Noted from the POCO conference that technical conferences are too narrowly focused
 - vii. Lee – Noted that we need to make Region 3 a destination and is willing to make a proposal and assist.
 - viii. Sean – Noted that making Region 3 a destination is tough and has the conference committee focused on bringing items in.

- ix. Mary Ellen – noted that as a practitioner that she never received better reviews due to publishing papers.
- x. Ken – should promote region early for other technical conferences.
- xi. Jim – closed out conversation stating that we had good discussion and input. He will turn this concept over to the conference committee to discuss further. Per the bylaws, the makeup of the conference committee is dictated in the Operations Manual.
 - 1. Bylaws:
Where Region 3 has administrative and/or financial responsibility the coordination and advisory support for Conferences and Conventions shall be the Region 3 Conference Committee. Refer to the Region 3 Operations Manual.
 - 2. Operations Manual:
The Committee Chair is appointed by the Region 3 Delegate/Director with concurrence of the Region 3 Executive Committee. The Chair's appointment is a one-year term with an additional one-year term at the discretion of the Region 3 Delegate/Director. One Vice Chair appointed by the Committee Chair with the concurrence of the Region 3 Delegate/Director. The Vice Chair shall be responsible for such tasks as delegated by the Committee Chair. The immediate past Conference Committee Chair, the Region 3 RSAC, and a past Region 3 Del/Director appointed by the Region Delegate/Director shall be Members-At-Large (MAL). The appointed past Delegate/Director shall serve as Mentor to the Conference Committee, Senior and Junior Southcon Directors appointed by the Region 3 Delegate/Director, and the current NCSE Chair. The Present, immediate Past and next two Future SoutheastCon General Chairs. One corresponding member from each Area/Area-Council not having conference committee representation. Headquarters Staff representing conferences shall be an "ex officio" member without vote.
