Agenda:

- 1) Director Vaughn began the meeting at 8:00pm.
- 2) The meeting agenda was approved.
- 3) The consent agenda, consisting of the minutes from the 19 August 2019 ExCom Meeting and reports listed in the information agenda, was approved.
- 4) Officer Reports
 - a) Director Report
 - i) Director Vaughn congratulated Theresa Brunasso for her recent election as the new Region
 3 Director-Elect and Kathy Land for her election as President of IEEE for 2020.
 - ii) Concur for Region 3 is up and running and we expect to use Concur for all Region 3 expense reports going forward.
 - iii) Director Vaughn noted that the Region 3 budget will be voted on at the November ExCom meeting, but no ExCom meeting is expected for December.
 - iv) Region 3 is still looking for volunteers for various region-level positions in 2020. Those interested should contact Jim Conrad or Jill Gostin.
 - b) Director-Elect Report
 - i) Director-Elect Gostin, who was on travel, encouraged everyone to read her Director-Elect report.
 - ii) Director-Elect Gostin also congratulated Theresa Brunasso for her election, and noted that Eric Grigorian is also looking forward to a new role in which to serve the region.
 - c) Secretary Report
 - i) Secretary Donohoe has posted all submitted reports to the meeting website, and encouraged those with other reports to submit them for posting after the meeting.
 - d) Treasurer Report (see report on webpage)
 - i) Treasurer Balsam went through the details of the current 2019 Region 3 budget and noted that the region is well within budget at this point, with little recent budget activity, and no major issues.
 - ii) Treasurer Balsam responded to questions relative to outstanding travel expenses that remain for 2019.

Also discussed were (1) the regional support for the Atlanta Section in its Atlanta Science Festival involvement, (2) regional support for the MOVE project, (3) the opportunity for Region 3 Young Professionals to provide travel support for appropriate conferences, and (4) support for Professional Activities in Jamaica.

SoutheastCon 2019 Chair Eric Grigorian gave an update on the current state of the conference close-out. All expenses are paid out, and one revenue item is outstanding (from IEEE Young Professionals).
