R3 Committees Core Purpose

- 1. Award and Recognitions shall assist the Region in formally recognizing, rewarding, and promoting excellence in all facets of the professional lives of its members.
- 2. Conference shall facilitate effective and timely conference planning and execution in the Region, especially SoutheastCon.
- Finance shall assist in the preparation of the Region 3 annual budget and periodically monitor the financial health of Region 3.
- 4. Member Communication shall support and facilitate the effective, seamless, and interactive sharing of information and knowledge with members of Region 3 and others.
- Nominations and Appointments shall serve as the Nominating Committee for Director-Elect as required in the IEEE MGA Operations Manual and Region 3 Bylaws. Additionally, the committee shall solicit nominations and recommend candidates for the other Region 3 officers, committee chairs, committee members, and IEEE leadership positions.
- 6. Operational Audit shall determine administrative and management effectiveness by performing operational reviews of other Region 3 Committees.
- Professional Activities hall assist the region in planning, organizing, implementing, and monitoring professional activities. It shall also encourage Sections to include professional activities in their programs and coordinate Region 3 professional activities with those of IEEE-USA.
- Section Support shall assist the Sections in as many ways as possible (1) to stimulate the interest of IEEE members, (2) to motivate members to volunteer, (3) to encourage professional and technical growth of all members, (4) to share best practices with other Sections, and (5) to form Engineering Affinity Groups.
- 9. Strategic Operations and Support shall assist in Region 3 Activities of a strategic nature.
- 10. Student Activities shall coordinate Region 3 student activities and provide advice and support for student activities to IEEE entities.
