

EMC Standards Activity: Standards and Regulatory EMC Forums Remain Informative and Well Attended

y column this time will review a major international forum sponsored by the Japanese Voluntary Control Council for Interference (VCCI). The VCCI has 1,300 member companies and associations in Japan as well as other countries. The members participate with the VCCI goal of protecting their respective radio and TV receivers from radio wave interference from information technology equipment. At the end of February this year, the VCCI held their International Forum 2009 in Tokyo at the U'Thant International Conference Room at the United Nations University. Approximately 200 people attended to hear from five speakers, each of whom had a specific topic of interest to Japanese manufacturers. The opening remarks and introduction of speakers were by Mr. Haruyoshi Nagasawa (Senior Executive Board of Directors, VCCI). The list of speakers and their subjects were as follows (the presentations were simultaneously translated into Japanese from the English presentations):

 Ms. Ge Hongmei of the Certification and Accreditation Administration of the People's Republic of China (CNCA) presented "Introduction of China Compulsory Certification System (CCC System) and EMC Standards."

- Mr. Don Heirman, Chairman of ANSI ASC C63®, presented "Proposed Changes to ANSI C63.4 (2003) to be included in the 2009 Version and Regulatory Implications Referencing C63.4"
- Ms. Soon Jung Moon of the Radio Research Agency in Korea presented "Certification Scheme" and "Korea: Today and Tomorrow."
- Mr. Stephan Winkelmann of Section 411 Market Surveillance Matters relating to EMC and R&TTE, BNetzA in Germany, presented "Market Surveillance and EMC Directive Revision and its Effects."
- Mr. Sergey Smirnov of GOST Asia in Russia presented "EMC Regulating in Russia: Standards, Procedures, and Schemes."

At the end of the presentations, there was an hour set aside where all the speakers were assembled on the stage to answer questions from the audience. Mr. Satoshi Shibata (Chairman of VCCI IRSC) hosted the panel discussion.

Most of the questions were aimed at further elaboration of the speaker's remarks. Of particular interest were the changes to ANSI C63.4. Questions on the measurement technique as well as the test site validation requirements for performing tests above 1 GHz and the video display to use on LCD screens during testing highlighted the questions asked of

ANSI C63.4 and C63.5 Workshops in Austin, Texas Just Prior to the 2009 IEEE International Symposium on EMC

On August 14–15, 2009, there will be two special workshops at the same venue as the IEEE EMC Symposium in Austin covering the 2009 edition of ANSI C63.4 (emission measurement methods required by the FCC) and the 2006 edition of ANSI C63.5 (antenna calibration) including the proposed changes for the 2009 edition. A highlight will be the introduction of a new test site validation technique using time domain concepts which will be compared to the validation technique stated in CISPR 16-1-4 (site VSWR). Attendees will get a chance to perform antenna calibrations in the lab and at a nearby Open Area Test Site provided by ETS-Lindgren. The workshops include several speakers who are technical experts on the subjects presented and who participated in the writing of the standards.
