5. ISCAS2004 Review process.
 - T. Tarim: Obviously, though we managed, there were some defects in the ISCAS'2004 review system.
 - H. Schmid. There were some errors in the review system. By means of a simple script, every paper could be downloaded by anyone.
 - I. Filanovsky. The number of reviewers was not sufficient. We have to find way to augment the number of reviewers; perhaps the authors of the papers should be obliged to do some reviewing.
 - H. Schmid. Perhaps, we have to send a help-letter asking to do some reviewing.
 - D. Frey. If there are many papers, how to improve their classification?
 - R. Fox. More people on RF reviewing are necessary.
 - W. Serdijn. There are difficulties with the classification of papers.
 - I. Filanovsky. We have to ask authors to put more keywords.
 - T. S. Lande. Demand on more subtracks. The list of subtracks should be prepared well in advance.
 - I. Filanovsky. I will analyze "Other areas in analog circuits" and will propose more subtracks. **Action Igor.**
 - T. Tarim. The crowded subtracks should be also divided into additional subtracks.
 - T. S. Lande. There should be more subtracks on RF circuits.
 - G. Gielen. Eliminate the overlap with the "circuits and systems for communications" track.
 - W. Serdijn. We should emphasize analog circuits for communications.
 - H. Schmid. Make distinction between building blocks and circuits for classification of subtracks.
 - G. Roberts. Give suggestions to the Program Chair of ISCAS2005.
 - T. Tarim. Eliminate "maybe" from acceptance status of papers.
