

1. Technology and Society magazine operations

Twenty-four papers were submitted for regular issues of T&S in 2006 (compared with 23 in 2004 and 30 in 2005). Of these, 5 were accepted with revisions, 6 were rejected following review, 4 received "revise and resubmit reviews" (one of which was accepted following resubmission and another of which was rejected following resubmission), 6 were rejected without review, and 3 were accepted as unreviewed features. In addition, an overflow paper from the March 2007 special issue was accepted and two papers were accepted after receiving "revise and resubmit" reviews in 2005. Despite the drop-off in unsolicited manuscripts from 2005, the current backlog is healthy (7 or 8 papers, not including the September 2007 issue, which is in production).

Keith Miller has assumed responsibility for the review of papers submitted in 2007. So far this year, 14 papers have been submitted for regular issues of T&S, including papers from India, China, Australia, and Azerbaijan. All papers have been sent out for peer review, and many are waiting for the third review to be returned. So far, one paper has been accepted with minor revisions, one has been provisionally accepted with major revisions, and one paper has been rejected outright. A fourth paper is not acceptable in its current form, and the authors will be invited to submit a substitution that is related to, but substantially different from, the original submission.

We recommend that the nonmember subscription price for T&S be set at the level recommended by IEEE staff. While increasing the price of T&S could increase the revenue to SSIT, we should be mindful of the possible negative consequences for our institutions, which pay for subscriptions.

SSIT Distinguished Service Award

The committee reviewed the nominations we received and voted to give the award to Joe Herkert.

The award makes provision for travel support for the awardee to attend ISTAS in order to receive the award. Joe has requested that we pay his registration for the conference instead of paying travel support. The committee recommends that we pay Joe's registration fee.

It is not too early to think of good candidates for this award and to start collecting relevant information and support them.

Barus Award

The Ethics Committee has researched a potential candidate for this award, Michael DeKort. Some background information has been supplied to all board members. I have written to the Coast Guard and to Lockheed Martin seeking any information they would provide, but have had no response.

Michael DeKort, the engineer who has been getting a lot of attention lately in connection with the Lockheed Martin US Coast Guard affair, has been identified as a candidate for the Barus Award. DeKort, for several years, as an engineering manager with Lockheed Martin, tried to correct various egregious defects in equipment for the Coast Guard vessels to be built under the Deepwater Project. Eventually, he was fired. The Inspector General's Office of the Department of Homeland Security recently investigated and validated most of his issues. DeKort recently testified before a committee of Congress.

Mr. DeKort is scheduled to appear in a segment of 60 Minutes on Sunday 20 May.
