

Publications Committee Report IEEE Society on Social Implications of Technology

IEEE SSIT Board of Governors Meeting March 17, 2007

1. New Editor for Technology and Society magazine

At the last Board meeting, the Board appointed a search committee for the new Editor of *Technology and Society* magazine. The committee comprised Michael Loui (University of Illinois at Urbana-Champaign, chair), Katina Michael (University of Wollongong), Janet Rochester (Retired), and Robert Whelchel (Tri-State University). The committee received nine complete applications by the November 1 deadline. During the month of November, the committee selected three finalists, but one withdrew. The committee interviewed the two remaining finalists by telephone conference call in mid-December. In addition, the chair called two professional references for each of the two finalists. After discussing the relative merits of the two finalists by e-mail, the committee arrived at a consensus ranking and reported to SSIT President Karl Perusich on January 8. With the consent of the Board, Professor Perusich offered the Editor position to Keith Miller (University of Illinois at Springfield), who accepted the offer.

Professor Miller starts as Senior Associate Editor of the magazine, and he will become Editor officially at the end of the term of the current Editor, Joe Herkert.

We thank the search committee members for their efforts.

2. Technology and Society magazine operations

Twenty-four papers were submitted for regular issues of *T&S* in 2006 (compared with 23 in 2004 and 30 in 2005). Of these, 5 were accepted with revisions, 5 were rejected following review, 3 received "revise and resubmit" reviews (one of which was accepted following resubmission, and another of which is currently under review following resubmission), 6 were rejected without review, and 3 were accepted as unreviewed features; 2 others are still under review. In addition, an overflow paper from the March 2007 special issue was accepted, and two papers were accepted after receiving "revise and resubmit" reviews in 2005. Despite the drop-off in unsolicited manuscripts from 2005, the current backlog is healthy (8 to 12 papers, not including the June 2007 issue, which is in production).

So far, three papers have been received in 2007. Keith Miller has assumed responsibility for the review of these papers.

Plans for future special issues:

September 2007 ISTAS'06 special issue

December 2007 Special section: Ethics Education and Liberal Education for Engineers
March 2008 Potentials and Limits of Cooperation in Fourth Generation Wireless

Communications

September 2008 ISTAS'07 special issue March 2009 Engineering Volunteerism In November, we responded to the draft IEEE best practice guidelines for timeliness in publications. We already meet the IEEE timeliness goals:

- At least 50% of papers receive the first decision within 90 days of submission
- 80% of papers have a mean submission to (electronic) publication time of less than 1 year
- The overall mean submission to (electronic) publication time is less than 2 years.

For the budget, we recommend that the number of pages allocated to the magazine be the same as last year. In addition, we recommend that the nonmember subscription price be set at the level recommended by IEEE staff.

3. Awards

Technology and Society magazine won two awards in the 2006 Society for Technical Communications (New York Metro Chapter) Publications Competition:

- An overall "Award of Merit"
- An "Award of Excellence" for the article "Portrayals of Engineers in *Science Times*" by Fiona Clark and Deborah L. Illman (published in the Spring 2006 issue of *T&S*.)

In 2006, the Board approved partial funding for the "Award of Excellence" winner, Kevin Bowyer, to travel to the ISTAS'06 symposium to receive the award. We recommend doing so again.

4. Electronic newsletter

Publication dates for the e-newsletter are set to coordinate with the BOG meetings (so minutes are available). Items for the e-newsletter should be sent to Karl Perusich (perusich@sbcglobal.net).

5. Sister society agreement with ASME Technology and Society Division

We have not made further progress on an agreement with the Technology and Society Division of ASME to provide T&S magazine to T&S Division members at a rate between the IEEE SSIT member rate (\$24) and the affiliate rate (\$83). We will also consider reduced registration rates for ISTAS conferences for T&S Division members.

Student Representative's Report Board of Governors Meeting, 17th March, 2007 Emine Cagin

A committee was formed in the September 2006 meeting to explore ways to improve student involvement in the SSIT. The committee members were Clinton Andrews, Brian O'Connell, Emily Anesta and Emine Cagin. Here are selected ideas from the brainstorming the committee did:

- Contact faculty that teach engineering ethics related courses
- Give all new IEEE student members free one-year SSIT membership
- Give free one-year membership to students who register for ISTAS
- Directly contact IEEE student branches (in progress, not fruitful so far)
- Linking SSIT chapters with IEEE student branches or other related student groups in their area
- Linking SSIT events (talks, gatherings) with larger society's events
- Your ideas?

A group of students from Ecole Polytechnique Montreal are in the process of creating the first SSIT student chapter. Emily Anesta and I assisted them on the rules and paperwork. We expect this chapter to be active in the beginning of the next academic year (September 2007).

IEEE SSIT Chapters Report

We had a few new SSIT chapters in 2006 (Ottawa, Western Puerto Rico, and the newly expanded Australia Chapter). Pittsburgh has just formed an SSIT Chapter and Switzerland is trying to reactivate itself.

The Australia Chapter has been extremely active; they recently had a successful planning day in Melbourne. Ottawa is planning a conference on the impact of FPGAs sometimes in March. Tokyo seems to have a meeting nearly every month on a variety of topics. Boston has had meeting nearly every month.

I have contacted the chairperson of each chapter, thanking them for their service and asking them to let me know about recent and upcoming activities. I have also requested photos for our web site. So far, I have not received much, but hopefully more will trickle-in over time.
