- Obligatory Statement Hanna Abdallah presented the latest revision of the obligatory document from IEEE regarding patents in standards and inappropriate topics for working group meetings.

- 4. Minutes The meeting minutes from San Francisco 2008 working group meeting were reviewed. These minutes were not approved as a quorum was not present.
- 5. Agenda The meeting agenda for the Nashville 2008 working group was reviewed and approved.
- 6. Guide Status Gary Engmann provided an update to the ballot of 605. The ballot has been recirculated with 7 or 8 comments. Gary will be making some comments to forward to Revcon.
- 7. Organization There was an opening for secretary which was filled by Chuck Haahr.
- 8. Article in Power Magazine Hanna Abdallah thought it would be a good idea to put an article in the IEEE Power Magazine to announce the new bus design guide. Hanna will write a draft with assistance from Dave Kelley. The draft is due by January 15, 2009. James (Bryan) Cain and Giang Tran will review the draft.
- 9. Possible Revisions for future IEEE605.
  - Short Circuit Force Calculations. Per Gary Engmann, the calculations for the decrement factor are more conservative and will result in a higher force than the 1.6 in the previous version of 605. Koushik Chanda asked a question about the half cycle

decrement factor. Discussion about the decrement factor ensued including whether this should be a quarter cycle or half cycle decrement factor. Gary Engmann to review.

- Insulator Strength Section Improvements. Discussion occurred in regards to insulator strengths and manufacturer's working strength. Hanna thought we may want to add an Annex about insulators in next revision.
- Converting the examples to metric Gary Engmann stated that the examples must be done in metrics as well as imperial units. Hanna will convert strain bus example to metrics and Randy Clelland will convert rigid bus to metrics. Chuck Haahr will review and convert any other examples to metrics. Conversions to be completed by January 15<sup>th</sup> and turned into Chuck Haahr.
- 10. Tutorial for future meetings. Hanna thought it would be a good idea to have a tutorial to go with the new guide. Hanna will try and have an outline completed by January in an attempt to have a tutorial in Kansas City, 2009.
