Action Items left over from Nashville:

1. Hamid will check the FERC definition of "transmission line". – Hamid will send to Deb to include in the minutes.

Ron sent copies of the goggle docs version of our revisions to Mason during the meeting. Mason will combine these with the previous version he has and send to Deb to be posted on the protected area of the WG website. (Note: this was completed and sent to Chuck for posting. **Deb will send a note to the group when it has been posted.**)

Hamid will check with IEEE-SA (Erin) to see if it would be worthwhile to set up a site for the WG on IEEE Central Desktop. This may make it easier to for multiple persons to work on the same document draft without a lot of effort combining versions or e-mailing the document back and forth. (WG members cannot write or save to the normal WG website.) Due by mid May.

A discussion was held concerning the definition of "substation". Yes, it does include switching stations and generating stations. Craig Preuss is creating a definition for use in the Cyber Security standard and will forward the definition to Deb when complete so that the two standards are in sync.

Craig suggested that we take a look at an EPRI document to see if any of the information would be useful for our document. Chuck has posted a link to the EPRI document on our WG website. Hamid, Deb, DJ, Ron, Alan, and Mike will review for applicability.

There was an open discussion about standard versus guide. Craig explained that the C37.240 Cyber Security is a standard because NERC was looking for a standard to refer to. Guidelines for Low, Medium and High would be based on individual utility definition. Perhaps 1402 should mimic the Cyber Security document. The standard versus guide decision was then tabled until the document is more complete.

The survey was discussed and tabled for this revision of the standard. It could possibly be included as an annex later by addendum. Gary Beane provided a copy of the survey to Hamid at the meeting.

The meeting concluded with a general discussion of security practices and concerns.
