 - f. EDS/SSC Anna Roesch has stepped down. Taking officer nominations. New chair: Dave Burnell. Plans for 2001 are 2 symposiums, 2 additional tech. Talks, chapter wide social meeting in Jan/Feb. Bank statement was submitted to Bob Berkovits. Admininistrative meeting last November to talk about attendance and new speakers for 2001.

 - i. IAS chapter Tom Patton reported on behalf of IAS.
 - j. PES Kirk Rae reported -- Substation technical talk at BGE and preparing for Feb. 20th Engineers week dinner. Invited everyone to sponsor a student. Distributed the forms.
 - k. Reliability Walt absent but submitted report and a travel request. He is asking for part or all of \$1500 to attend a one day conference in July.(destination still unknown) to attend Reliability Congress.
