## The IEEE Booth at the Brass Ring Job Fair, 5/22 and 5/23/00

The weather was threatening and I was apprehensive, but the lure of on-the-spot job interviews conquered the obstacles. The Job Fair (JF) attendance and the IEEE Booth location were great. Continuous hits at our booth resulted in 50 new registrants for follow. Each received an employment-oriented IEEE Application Package plus selected literature.

With one week to the JF, I realized that all I had was *Scanners* given to me by Don Rickerson, and I called Jackie Hunter for help. She responded splendidly, called Sharon Strock at Hoes Lane and Bernice Evans at IEEE-USA for suitable IEEE literature. That team provided timely delivery of applications and other pertinent literature. The IEEE Application Package comprised: a Y2K membership application, plus Electronic Information Services, Employment Assistance Services and Careers and Policy brochures. In addition, each client was given a *Scanner* and told to contact chapters of interest to attend a local meeting based on the IEEE Booth Registry and meet the people in their discipline.

The IEEE Booth was located just across the walkway from the Brass Ring (BR) Registration Desk and was a busy location. I was apprehensive about locating the booth in the registration area, offered to Don Rickerson by BR, and deferred the choice to Jim Allen, who had been negotiating with BR for a suitable location. Jim accepted, sight unseen, and lucked out. BR applied icing on the cake by providing a tripod and placards for booth identification. We didn't lack client attention, but client interest took a little more doing.

Jan Aminoff, who has served with me in the past, was in Sweden. He may have reservations at the booth location, notwithstanding the client traffic, because he brings his PC and a projector to the JF and demonstrates JAVA software applications that invariably draw interest clients to the booth. But, we'll adapt and improve our outreach for prospective members.

In conclusion, Jim Allen's efforts to get our booth located in a high-traffic area paid off. A few minor adjustments to allow projection at the booth, a well-considered selection of IEEE literature aimed at JF candidates, and possibly, since Jan brings his PC to the JFs, if we negotiate a phone line at the booth, we can display IEEE Web Sites for discussion with the clients, to complete the productive stance for this phase of our recruitment activities. Additional inducements would help, i.e., reduced membership rate while unemployed, interactive job/client matching, etc.; however, to facilitate registration follow-up with client membership. To the IEEE volunteers who haven't tried a JF, I suggest, try it, like Mike, you'll like it.
