

#### Minutes of the ExCom Meeting on 6/4/08

#### Meeting called to order by Ram Sivaraman at 6:10PM

- Approval of last meeting minutes approved

#### **Chapter Reports:**

#### Com Society:

Lu Chang gave the presentation. They meet on the second Wednesday of every month (except July and August) at National Semi. They have Ops meeting every month. They also hold a joint Workshop with NATEA. The have 84 Fellows, 376 SMs and 274 Assoc. members based on the SCV section statistics. Their seminar topics include Wimax, Telepresence, Nextgen Wireless BB, 4G Smart phone, Femto cells, Location based technology. In June, they are having Mobile TV/Video workshop. Their registration and payment system for Workshop is by PayPal. They have an account with Wells Fargo Bank and have a balance of \$4000.

#### **CPMT Society:**

Mudasir Ahmed presented the summary of activities. They have 468 members out of which 48 are SMs and 10 are Fellows. They added 21 new members this year. CPMT started in 1955. Second Wednesday of every month, they have a dinner meeting. Every 4<sup>th</sup> Thursday, they have a lunch meeting. They have a summer picnic in July. They had arranged a bus trip to Reno for the Electronic Components Technology Conference and it was very good. They had talks on Printable Electronics, Sustainable Information and Semiconductor Manufacturing. CPMT is very rich! They have a bank balance of \$64,094 on an 18 month budgeting cycle. (Many ExCom members wanted to buy shares in CPMT and wanted to know whether they pay dividends!)

#### **Computer Society:**

Eric Louie gave the presentation. They have 3 lectures per year. Some of the speakers were: Alan Harvey (Google), Mike Carey (BEA), Don Chamberlain (IBM). They are going to have a Workshop on "New Frontiers in Computing" on July 19<sup>th</sup> with Stanford. They use PayPal for registration. They have a bank balance of \$3101 and a hefty \$30,000 in a CD.

#### **Consumer Electronics Society:**

Tom Coughlin presented the results (Chair Gary Sasaki was not present). They meet on 3<sup>rd</sup> Tuesday of every month at HP Campus in Cupertino. About 50 people attend their meetings. Every January, there is a Consumer Electronics Show in Las Vegas. They have 11 meetings per year. For the January meeting, they down loaded the CES meeting. They had talks on Note Book Displays, Cyber Security, Flash Memory, Wireless USB etc. They have a bank balance of \$4518.

#### **Power Electronics Society:**

Tom Weniger is trying to resurrect the Society. Ari Shrager will be the new Chair. They have \$4000 at Bank of the West. They have to access SamIEEE to get hold of their members.

#### **HP-35**

We have agreement on the text of the citation:

The HP-35 was the fist handheld calculator to perform transcendental functions (such as trigonometric, logarithmic and exponential functions). At the time, most existing calculators could only perform the four basic functions: addition, subtraction, multiplication and division.

The HP-35 and subsequent models have replaced the slide rule, used by several generations of engineers and scientists. The HP-35 performed all the functions of the slide rule to ten digit precision over a full two-hundred-decade range.

# Silicon Valley Engineer Testifies before Congress on Need to Retain Talented High-Tech Students and Professionals

WASHINGTON (12 June 2008) — Congress should make it easier for foreign graduate students and engineers to remain in the United States, Silicon Valley engineer and entrepreneur Lee Colby told a congressional subcommittee at a hearing on Capitol Hill today.

Speaking before the House Judiciary Committee's Subcommittee on Immigration, Citizenship, Refugees, Border Security and International Law, Colby testified in support of three permanent immigration reform bills introduced by subcommittee chair, Rep. Zoe Lofgren (D-Calif.).

Lofgren's proposals (H.R. 5882, 5921 and 6039), which enjoy bi-partisan support, would:

- 1. Increase the annual number of visas granted to professionals in science, technology, engineering and mathematics (STEM) by exempting from the cap on employment-based (EB) permanent visas foreign students who earn graduate STEM degrees in the United States;
- 2. Eliminate restrictive per-country limits on EB admissions; and
- 3. Authorize the re-issuance of EB visas that went unused because of processing delays.

Exempting U.S.-educated STEM graduate students from permanent EB visa limits would help our nation retain talented individuals who are already here.

"Graduates from American schools are among the most sought-after employees in the world," Colby said in written testimony on behalf of IEEE-USA. "This is especially true of students who receive master's and Ph.D. degrees in STEM fields. America has already invested in these students' education. The students speak English, have lived here for several years and, to qualify for an employment-based visa, have a job. It is in America's interest and Americans' interest that we allow them to put their talents and education to work here.

"Remember, it is not a question of whether the talented graduates of our schools will get jobs, only of where these jobs will be located. If we force them to leave, the jobs they create will not be in this country, but rather in whatever nation had the foresight to accept them."

Lofgren's bills would give U.S. companies greater access to talented workers from around the world.

"We need to educate more of our own students in these fields, but the United States does not have a monopoly on talent," Colby wrote. "There are hard working, innovative and smart people all over this planet, many of whom would apply their skills here, if given a chance.

"Congress needs to give them that chance."

Colby, who lives in Sunnyvale, Calif., worked for 36 years as an electrical engineer for Hewlett-Packard. Lee Colby and Associates, which he started in 1997, consults on circuit designs for some of the



world's leading technology companies. He served as chair of the IEEE's Santa Clara Valley Section in 2005.

"Balanced reforms in the nation's legal permanent and temporary admissions programs are particularly important if U.S. employers and U.S. workers are to compete and succeed in an increasingly knowledge-based, technology-driven global economy," Colby wrote.

#### Resolution

- Santa Clara valley Section and the Silicon Valley Engineering Council have several similar activities
- In comparison to the Santa Clara valley Section, it seems that local IEEE Chapters of national/international societies, councils and affinity groups more closely represent the typical engineering society members of Silicon Valley engineering Council
- Separately, the Silicon Valley Engineering Council has lost its way

#### Therefore,

1. If the situation does not improve substantially at the Silicon Valley Engineering Council Meeting on June 25, 2008, then the attached letter of June 26, 2008 will be mailed to the Silicon Valley Engineering Council.

This attached letter of June 26, 2008 notes that the IEEE Santa Clara valley Section's membership in the Silicon Valley Engineering Council will not be renewed. Effective July 1, 2008, the Santa Clara valley Section of the IEEE will establish a liaison relationship with the Silicon Valley Engineering Council. It further notes that the Silicon Valley Engineering Council is welcome to market to and to accept other units of IEEE such as local chapters of its national and international societies, councils and other affinity groups as members of the Silicon valley Engineering Council.

- 2. The IEEE Santa Clara Valley Section will review its relationship with the Silicon Valley Engineering Council each spring. If the Silicon Valley Engineering Council does not achieve robust change, then the attached letter will be mailed in June, 2009 or earlier.
- 3. If the situation at the Silicon Valley Engineering Council does not improve robustly from an IEEE Santa Clara valley Section perspective, the IEEE Santa Clara Valley section will withdraw completely from the Silicon Valley Engineering Council by June 30, 2010. In that case, no liaison relationship will exist.
