- 4. Exhibits Hours: 7:30 to 8:30 AM during registration, 12:00 to 1:30 PM during lunch, all breaks and 5:00 to 6:00 PM during the reception. It will be noted in the program that access to the tabletop displays is available during the presentations, but that the displays will not necessarily be staffed during that time.
- 5. **Booth staff**: No extra fee to man the tabletop displays. If a salesperson also wishes to participate in the meals offered (continental breakfast, lunch, refreshment breaks and the reception), the meals only fee of \$75.00 per person must be paid in advance. There is one full registration included for every level of sponsorship.
