### **Meeting Notes:**

The MCC had an informational meeting via WebEx on October 13<sup>th</sup>, 2020. We discussed two main topics for implementation.

1) The Member Communications eNotice Initiative – This Monthly Email Blast will invite all members of Region 3 to participate in virtual meetings that are hosted by any Sections in our Region. An email will be sent out to all Section Chairs each month during the 3<sup>rd</sup> week, requesting that Section's submit the meetings/links for registration to sessions that they welcome other R3 attendees to participate. In the midst of Covid-19 and Zoom environment, it would be advantageous to let all members to attend any of the meetings that they wish to attend. This is a win-win for knowledge sharing and professional development for our members. During the 4<sup>th</sup> week, or end of each month, another email will be sent to all R3 Members letting them know about the upcoming meetings for the following month. This eNotice initiative will remain in effect throughout Covid-19 and possibly beyond, if it is effective and has successful participation.

Currently, there are 2 virtual meetings that will be available for R3 in November, links to both will be forthcoming.
