

All approved Pandemic Projects have been funded. (7 projects, \$6,400)

Section and Chapter Treasurers should be in the process of year-end financial close-out. IEEE sent out a reminder email alerting all Treasurers. In summary:

- ---All 2020 tax reporting, (1099 forms) should have been completed by Jan 8th
- --- Financial close out needs to be complete by Feb 19, 2021 to be eligible for the additional 10% rebate bonus. The final date to be eligible for your Section rebate is Feb 28, 2021 and your reporting needs to be completed no later than that. Account for all transactions in NetSuite or use the Bank Upload Templates. Templates can be requested by emailing finance-solutions@ieee.org. When your reporting is complete, send a confirmation email to this same address.
- --- Remember to make account signing changes and complete COI certifications if your unit has changes in Officer positions.

responsibilities for maintaining its operations (including SoutheastCon) in times of economic challenges, and year-to-year budget variations such as an activity that regularly occurs every three years. The reserves also provide a basis for initiatives to respond to the needs of the organization to maintain its relevance and effectiveness. Consistent with Section 9.1.1.3.b of the MGA Operations Manual, the FinCom shall establish the amount necessary to provide for uncertainty and multi-year expenses and annually inform the Delegate/Director as to the reserves available for initiatives.
