The changes to our Bylaws, which included the changes affecting our Areas, were approved by the MGA Board. Beginning in January of 2022, Region 3 will have 5 Areas. The MGA Board also approved the closure of the Tennessee Council

A few other items from the Board Series:

Sections Congress 2023 will be held September 11-13 at the Shaw Center in Ottawa, Canada

MGA Surplus is being used for staff-developed IT projects

Three R3-submitted projects are being moved forward to MGA Committees for review and possible implementation ideas (the remaining projects will need to be addressed with other IEEE units or at the region level for potential support)

YP Mentoring Hybrid Meeting Tool Set Member Engagement / Membership Challenge

Technical Co-Sponsored Conference fees will continue in 2022 as in 2021 -- TCS charges passed to the Geo Units/Conferences will continue to be \$1000 + \$15/paper. Actual cost is **\$1,450/conf** + **\$22/paper**, with MGA paying the difference. A motion regarding TCS fees in 2023 will be considered in November

Updates on the Sections Congress 2020 recommendations were provided, including pilots that are already being implemented, pilots under consideration, existing programs and projects that are related (including the Industry Relations Platform project), and cost analyses underway. The recommendations are:

Consideration of a multi-year membership commitment.

Provide a high value Continuing Education program for working professionals. Improved resources for sections to serve industry professionals and track industry contacts at the local level.
