Presentation of the R3 2021 Budget YTD

We are now in the process of drafting the Region 2022 budget. All Committee Chairs should begin to plan for their budgetary needs for their respective committees in 2022. Chairs will be contacted later this month for their input to the budget.

NextGen Financials status: Staff are preparing templates for Geo Units to assist in categorizing Geo Unit YTD transactions. Rather than waiting for the templates, Treasurers may log into NextGen and categorize their previous transactions online. NextGen staff continue to work on other operational issues. Also attached is a very informative document written by Brian Conant, Atlanta Section Treasurer, as a "Quick Start" guide to using NextGen. Unit Treasurers are encouraged to review the useful information it contains to help in getting started with and navigating NextGen.

The previously requested transfer of R3 Conference Funds account to the R3 Long Term Investment account appears to be making process at HQ.
