Treasurer's report for December 2021:

Presentation of the R3 2021 Budget YTD. The transactions made since the November EXCom meeting consisted of travel expense reimbursements for the R3 Budget Planning meeting on December 4th, PACE fund reimbursements to the Atlanta, Melbourne, Richmond and Mobile Sections for various approved Professional Development projects/activities, and some end-of-year income from our IEEE Allocation account.

Joe Pennisi, the incoming R3 Treasurer for 2022 and I met for 3 1/2 hours this month to discuss R3 Treasurer duties, responsibilities and process. We also jointly processed various transactions in NextGen. Joe is well versed in financial accounting principles and well prepared to take on the R3 Treasurer position. I will continue to work with Joe early in the new year, as needed, to help complete the R3 financial close and 2021 audit.

NextGen Financials status: IEEE Staff are preparing templates for Geo Units to assist in categorizing (tagging) Geo Unit YTD transactions. If you are a unit Chair, Vice Chair or Treasurer, you should have received an updated email notice from IEEE MGA on Nov 5th regarding the financial close out process for 2021 which reverts back to a close date in February, similar to past years. To qualify for the 10% rebate bonus, the transactions will need to be submitted by the 18th of February (3rd week in February). Treasurers will have until the 28th of February to provide all tagged transactions to qualify for the rebate. Please refer to that notice and adhere to the steps outlined in the memo. Let me know if you did not receive the email or if you have any questions.
