Agenda:

- 1) Director Grigorian called the meeting to order at 8:00pm.
- 2) The meeting agenda was approved.
- 3) The consent agenda was approved which consisted of the minutes from the 26 August 2024 ExCom Meeting and reports listed in the information agenda.
- 4) Officer Reports
 - a) Director Report
 - i) Our thoughts and prayers are with those recently affected by the two major storms, especially in Florida and North Carolina. We recognize each and every one of our dedicated MOVE volunteers that are providing the much needed humanitarian support in these areas.
 - ii) Director Grigorian recognized Mary Ellen Randall in her election as 2025 IEEE President-Elect and Barry Tilton in his election as 2025 IEEE-USA President-Elect.
 - iii) Preparations continue for the IWRC in Aerospace and Defense to be held in Huntsville, AL in December. If you are aware of any organizations within your Section that are interested in participating in the event, please contact Director Grigorian. The goal is to bring funding associated with the CHIPS Act to Region 3. More information on the conference can be found at <https://iwrc.ieeeusa.org/alabama/>.

- iv) The Eta Kappa Nu Leadership Conference will be hosted in Charlotte, NC in November. The Region 3 Planning Meeting for 2025 will also be held in Charlotte in December.
- v) Director Grigorian, Joe Pennisi, and Sonya Dillard participated in the MGA training for treasurers last month as they rolled out the changes to NextGen. These training sessions are also made available to all sections through a series of webinars.
- b) Director-Elect Report
 - No report.
- c) Secretary Report
 - Secretary Donohoe noted that there were some reports submitted late that will be posted to the meeting website after the conclusion of the meeting.
- d) Treasurer Report
 - Treasurer Pennisi submitted his report but was unable to attend the ExCom meeting.
- e) Past Director Report
 - Past Director Brunasso noted that Region 3 voted to approve Pat Donohoe and Andy Seely as candidates for 2026-27 Director-Elect at the October ExCom meeting. The Past Director also congratulated Mary Ellen Randall in her election as 2025 IEEE President-Elect.
- 5) Action Agenda – There were no action items.
- 6) Discussion Agenda
 - a) Presentation of the Proposed 2025 Region 3 Budget
 - The ExCom discussed the proposed 2025 Region 3 budget (spreadsheet submitted by Treasurer Pennisi). The Region 3 FinCom will meet in November to develop the final version of the budget which will be presented for approval at the November ExCom meeting.
 - b) SoutheastCon 2025 Update
 - Thirteen papers have been submitted so far and another Call for Papers is going out this week. Jim Conrad has approached the sponsors of the HKN Leadership Conference regarding support for SoutheastCon. The planning committee is putting together details for the Industry Days which will be held on Thursday and Friday of the conference.
 - c) SoutheastCon 2026 Update
 - Ebonee Walker noted that the conference had received additional seed funding from the Region due to some larger deposits than initially expected. The contract with the Von Braun Center is in place. UAH is working on the hardware competition, and it was noted that the hardware competition rules should be available for review early in 2025. The planning committee meets monthly and the Technical Program Committee is in place. The committee is currently developing sponsorship letters.
 - d) SoutheastCon 2027 Update
 - Conference Committee Chair Joe Juisai gave an update on the selection of the site for SoutheastCon 2027. Two organizational units have submitted proposals for SoutheastCon 2027. The Jamaica Section proposes to host the conference on March 11-14, 2027, in Montego Bay at the Hilton Rose Hall and Montego Bay Convention Centre. The Canaveral, Daytona and Orlando Sections propose to host the conference on April 15-18, 2027, in Daytona Beach, FL at the Hilton Dayton Beach Oceanfront Resort. Both prospective hosts will make presentations to the Conference Committee on November 18. The Conference Committee will evaluate the proposals and present recommendations to the ExCom.
 - e) Awards and Recognition
 - Awards Chair Devon Gayle noted that the Region 3 Awards Portal is active, and the nominations deadline is approximately one month away (December 1). The committee expects to receive several nominations for the Cybersecurity Scholarship in its inaugural year.

The IEEE-USA 2024 award nominees were judged in October and the winners will be announced shortly.

f) Life Member Affinity Group

Region 3 Life Member Coordinator Jacob Kulangara noted that the Life Member Conference will be held June 11-13 in Boston, MA sponsored by Tufts University. The Life Member Committee is planning to donate \$20K for hurricane relief. Sections were encouraged to make sure that each Life Member Group holds the required number of meetings.

g) Industry Engagement – no report

h) MGA Excess Funds – Project Updates

Brian Page provided an update on the Innovate for Impact Student Competition which will be hosted by the Atlanta Section and funded by MGA, Region 3, the Atlanta Section and the Communications Society. The competition is open to all IEEE Student Members in Regions 1-7 and 9. Registration for the event will close on November 15. The regional competitions will take place on December 7 and the final competition will take place on December 9. Teams must identify a challenge in their region that must be solved using three of the following technologies: computing, communications, robotics, power, cybersecurity and AI.

i) Innovation, Workforce and Research Conference – Aerospace and Defense

Director Grigorian noted that IWRC will be coming to Region 3 in Huntsville in December.

7) Old Business - Review of Action Items from Last Meeting

a) Director Grigorian called for all Sections having elections to submit nominating committee names during this election cycle. Area Chairs noted that many Sections are struggling to find candidates. There have also been issues with candidates running for multiple Section offices.

b) Secretary Donohoe will send eNotices to Sections regarding collection of (1) 2024 Section budgets and (2) Region 3 Section events associated with the 140th Anniversary of IEEE.
