Area 4 Report: Election Addendum, November 25, 2024 P. Kuban

Summary: Although we all tried, only the Memphis section has been successful with the new election process. Several people willing to serve were forced to step down due to term limits. Some previously willing to serve stepped down due to the added burden of election process compliance. Some willing to serve may be shut out due to lack of signatures. Perhaps the signature threshold was set too high for small sections.

Section
Central Tennessee:
Progressed through Petitions period deadline. Only one nominee made it by the nomination deadline due to unfamiliarity with the process. Many petitions filed. Of 10 petitioners, only 2 have enough signatures, although many want to serve. Can they extend the petition deadline to get more signatures? "Populate Election Ballot" is grayed out, so not able to launch election.
Chattanooga:
Progressed through Petitions period deadline. No petitions filed. The 3 nominees only include Treasurer and 2 Membership Development (no chair). Prior chair decided to step down. vTools is waiting for someone to "Announce First Slate," but this is somewhat useless without a chair nominee.
East Tennessee:
No elections until next year.
Evansville-Owensboro:
Progressed through Petitions period deadline. No petitions filed. All candidates are running unopposed. Still no approval of single candidates from Director. "Populate Election Ballot" is grayed out, so not able to launch election.
Lexington:
No elections until next year?

Memphis:
Progressed through Petitions period deadline. Many petitions filed; 3 have enough signatures. Some candidates still running for multiple offices. "Populate Election Ballot" is grayed out, so not able to launch election, even though it looks like everything is good.
