LMAG with less than 2 v-Tool events in the year is considered inactive and will be on probation or potentially dissolved in the following year; **new LMAG is exempt from this requirement** in the first year of formation. **LMAG with 6 LMAG (or joint LMAG) events listed in v-Tools in the year** is considered a good standing LMAG and is eligible for expense reimbursement for any subsequent event with preapproved fund request form and by submitting foundation expense report form to LM Coordinator; LMAG will also receive full rebate in the following year. **LMAG with more than 6 LMAG (or joint LMAG) v-Tool event in the year** is qualified for self-nomination in the following year for consideration for regional LMAG Achievement Award of LMC.
