Attached is the Fall Report on Conferences.

The first pages are the usual summary, details of which we can discuss at the meeting.

The remaining pages concern a proposed merger of the PLANS conference with the ION Spring Meeting. What is attached is the summary of the last phone teleconference between the IEEE PLANS executive committee and representatives of ION. This is followed by a comparison spreadsheet of differences, similarities and proposed merged conference characteristics.

Finally there are initial comments that I received back from Mary Ann Dewald of IEEE Conference Services regarding this proposal. Understand that the version I forwarded to Mary Ann was an earlier draft, and I think the last teleconference addresses some of her concerns.

The 2004 ION GPS Conference is in Long Beach, the same week as our meeting in San Antonio. The next meeting to discuss the merger is in Long Beach, same day as our meeting, 22 September.

Please be prepared to offer opinions and ideas, as AESS BOG will necessarily be asked to approve this merger, if it is to proceed.

I think the biggest item we will need from the PLANS executive committee and ION is a draft MOU, defining the future co-sponsorship.

Meeting Notes form Aug 31 Telecon between ION and PLANS

The following is a summary of the meeting between the ION and PLANS representatives to discuss the possibility of merging PLANS with one of the ION conferences.

Introduction - The reason for the desire to merge an ION Conference and PLANS from the ION representatives' perspective was that there are too many Spring Navigation conferences and it is difficult for all parties to put on good conferences. Therefore the desire was to merge two conferences and create a single higher quality conference. This would give our customers more value for their money.

The PLANS representative agreed and also indicated that the volunteer nature of the PLANS conference leads to inconsistencies in the conference, especially as we have to become more digitized to meet our customer's expectations.

The PLANS representative then stated that this was a discussion, not a negotiation. The topic of a merger has been brought to the AESS BOG. The BOG representative expressed some reservations. The reservations included the character of the conference (size and social atmosphere), finances and copyright ownership.

We then discussed many of the issues in the comparison chart (Comparison Chart V2.doc). The following will attempt to summarize the discussion on each topic.

Which meetings would be merged - The desire from the ION is to merge their Annual Meeting (June time frame) with PLANS. Having the merged meeting in the late April time frame, the current time frame for the PLANS meeting, appeared reasonable to both groups. The Annual ION meeting attendance is the 200-300 range. The PLANS meeting is in the 300 range. Some conference participants attend both conferences, though the level of joint participants is not known. (Not mentioned at the telecon: The Lowes can accommodate another 130 rooms over the current PLANS commitments).

Annual or Biennial – Two options were discussed. One option is a IEEE/ION PLANS meeting in even years and a separate ION meeting in odd years. The other is an annual PLANS meeting with alternate primary sponsor (IEEE/ION PLANS in even and ION/IEEE PLANS in odd years). Both seemed acceptable to the ION. PLANS did not indicate a

preference. (Note - I think some ION council members will be more receptive to the biennial option because it allows the odd years to have a more military focus. - Penny)

Tutorials – The goal of both groups for the tutorials is the same, which is to provide a better conference experience to their customers. The ION only has tutorials at their Sept meeting. The June meeting does not have tutorials. In Sept the ION typically contracts with another organization (e.g. Navtech) to put on the tutorial sessions. PLANS, typically, provides tutorials by contracting with individual instructors. The ION does not have a requirement to contract with one organization but typically does not get viable proposals from multiple tutorial providers. .. However, the ION is flexible. The tutorials at PLANS have been of good quality. But PLANS does have some poor ones, occasionally, because of poor publicity or instructors. The PLANS tutorial process is functioning okay, but can always be improved.

Technical Program - The organizations are very similar in structure and duties for Tech Program chair, Track chairs, and Session Chairs. The paper and abstract selection process is also similar. The biggest difference is that PLANS publishes the proceedings before the conference and ION does it after. The PLANS representative stated that the key item was to have papers available at the conference. The ION does and will do this by making papers available via hard copy with 1 day response time or via electronic download. The PLANS representative indicated that this may be acceptable to PLANS, since the need for a bound paper proceedings is fast becoming obsolete. The ION has rigid scheduling of session, which is viewed favorably by the attendees. The PLANS has received comments both for and against rigid timing. PLANS commented that we are flexible on this subject.

Registration, Abstract/Paper Submittal, Conference setup etc - The ION National Office does this for ION. The PLANS uses volunteers or contracts to individual companies. For PLANS sometime contracting works and sometimes it doesn't. A big benefit of the merger to the PLANS conference would be a professional group taking care of the details of the conference.

Finances - The ION indicated that it would provide financial data in the format and detail required by the IEEE, including audits. The ION, because it is non-profit, has external independent audits to maintain it non-profit status. The PLANS representative raised the idea of contracting the ION for the 2006 for a fixed fee rather than a shared financial model. The ION said they would consider this, especially for the first joint conference, but probably wouldn't like this to be a permanent arraignment. The ION took the action to brainstorm ideas for different ways to handle the finances. No recommendation or preferred method to handle the finances for the merged conference was identified.

Copyright - The issue of who owns the copyright was discussed. The ION does not have the author sign over the copyright to the ION as the IEEE does. The ION only gets specific rights from the authors. The ION indicated that they were okay with the IEEE owning the copyright, but they would want a no fee license for all copyrights. The purpose would be to sell proceedings and individual papers. The ION believes that the customers it provides conference papers are distinct from the customers to which the IEEE provides PLANS

conference papers. The issue of first right of publication was briefly discussed without any conclusions being reached.

Conclusion – The discussion between the ION and PLANS representatives went well. The conferences have differences and similarities. Some issues will be difficult to resolve. However, it was agreed that we should continue the discussions to determine if and how we want to merge the conferences. The PLANS representatives took the action to get additional guidance from the AESS BOG regarding their recommendations or constraints to a merger. The ION will continue to discuss the feasibility of the merger to ensure that they want to merge and, as appropriate, identify ideas regarding how to merge. The ION and PLANS representatives will meet the evening of Sept 22 at the ION Conference in Long Beach CA to continue the discussion. The ION will setup the meeting.
