The following is the Switchgear Assemblies Subcommittee report to ADSCOM for the the 3-Oct--2006 meeting in Milwaukee, WI.

The Switchgear Assemblies Subcommittee has a current menbership of 26, with normal attendance at meetings in the range of 25-30 persons. Please see "Switchgear Assemblies Subcommittee Roster and Mailing List" available on the Switchgear Committee web site.

The subcommittee has active working groups as follows:

- C.37.20.1b (LV ME Switchgear) amendment to C37.20.1, submitted to RevCom 27-Sept.
- C37.20.2 (MV Metal-Clad Switchgear) revision, second WG meeting in Milwaukee
- C37.20.6 (G\&T Devices) revision, second WG meeting in Milwaukee
- C37.20.7 (Internal Arcing Tests) revision, conditionally approved by RevCom in June, 2006, recirculated once for legal issues, and second recirculation to occur in early October. Expect to resubmitt to RevCom by 16-Oct.

Working groups for revision of C37.20.3 (MV MEI Switchgear) and C37.20.4 (MV
Switches for MEI Switchgear) will be formed in Milwaukee. C. Ball will chair both WGs.
The content of C37.22 will be consolidated into C37.20.4 as part of the revision.
Reaffirmation ballots on C37.20.3, C37.20.4 and C37.121 (Unit Substations) were successful and all three were submitted to RevCom on 31-August.
