V. Business

- a. The chair of the group presented a table that collectively defines test duties for rating classes. This table will be discussed again and perhaps inserted at the next meeting.
- b. The latest draft revision of the document was discussed.
 - i. The term "P60" was suggested as a new nomenclature for the preconditioning shot, and met continued objection. This will be discussed at the next meeting.
 - ii. Subsection "e" was added to section 4.2 General to account for back-to-back application
 - iii. The difficulty to understand "positive sequence" and "zero sequence" capacitance was discussed. It will be revisited at the next meeting.
 - iv. It was brought up that perhaps a back-to-back rating should be added to the standard.
 - v. There was a disagreement about whether the testing order for C2 class rating should be mandatory, preferred, or other. One point for it being mandatory was that the inrush current in the preconditioning contributes heavily to the condition of the device during testing.
 - vi. 4.6.6 Table 2 notes should be revisited.
 - vii. The term "Non-Destructive Restrikes" (NDRS) is introduced. This was discussed at length and with respect to different voltage levels. NDRS will be written into the standard for the next ballot and will be further discussed at the next meeting.
 - viii. C37.60 Draft 9 was informally referenced in the meeting during a discussion about acceptable restrikes. This topic should be revisited.
 - ix. It was suggested to change "v" to "u_r" for IEC harmonization
 - x. There was a small disagreement about whether a section for damping components is needed.
