

**Minutes of High Voltage Switches Subcommittee Meeting

**WG PC37.30.1 - IEEE Standard Requirements for AC High-Voltage Air Switches Rated Above 1000 V**

**WG PC37.30.1a – Amendment to IEEE Standard Requirements for AC High-Voltage Air Switches Rated Above 1000 V**

**WG PC37.30.3 – Standard Requirements for High Voltage Interrupter Switches, Interrupters or Interrupting Aids Used On Or Attached To Switches Rated for Alternating Currents Above 1000 Volts**

- Meetings were held on April 23 , 2017. See the published minutes of the meeting.
- Danny Hoss WG Chair, reported that the document has been sent to REVCOM.

**WG PC37.30.4 - Standard for Test Code for Switching and Fault Making Tests for High Voltage Interrupter Switches, Interrupters or Interrupting Aids Used On or Attached to Switches Rated for Alternating Currents Above 1000 Volts** (Formerly IEEE Std 1247™ -2005).

- The meeting was held April 23 and 24, 2018. See the published minutes of the meeting.
- Mr. Bill Hurst, the WG Chair, Recirculation ballot was completed. The document will be recirculated with the intent of going to REVCOM before the end of the 2018.

**WG PC37.30.5 – Standard for Definitions for AC High-Voltage Air Switches Rated Above 1000 V**

- The meeting was held on April 23, 2018. See the published minutes from the meeting
- Carl Reigart, the Working Group Chair reported on progress of the WG. Recirculation ballot was completed with a 96% approval and no comments to resolve. The document is being sent to REVCOM.

**Old Business**

- 2018 Projects Deadline -
  - WG PC37.30.1: active WG, Issues with the C37.100.1-2017 has resulted in the document to revert to C37.100.1-2007. The WG expects to ask for a PAR extension following the Fall 2018 meeting. New Deadline is 12/2020.

- WG PC37.30.3: active WG, expect to meet the deadline.
- WG PC37.30.4: active WG, expect to meet the deadline.
- WG PC37.30.5: active WG, expect to meet the deadline.

### **New Business**

- Ken Harless and Kyle Stechschulte resigned as Chair and Vice Chair of C37.30.1. Donnie Swing was nominated and voted the new Chair. Thomas Kohler was nominated and voted the Vice Chair.
- Bill Hurst announced there may be a change to tables 3&4 in C37.30.4.
- Frank DeCesaro brought the Definition of “Visible Break” to the committee for comment. The committee agreed with the definition. The definition is as follows:  
*Visible Break - a gap between conductors that can be visually verified, and meets the dielectric requirements in the relevant product standard.*
- Devki Sharma – Proposed that a standard for Motor Operators be developed. The committee agreed to form a taskforce to make recommendations whether it was needed or not. The following members agreed to participate on the TF:
