Minutes of WG PC37.12 Guide for Specification of Circuit Breakers Monday, October 15th, 2018

- II Introductions

 Meeting opened with 5 of 20 members and 21 guests. A quorum was NOT present.
- III A call for knowledge of essential patents was made, no respondents.
- IV No comments to the minutes from the Spring, 2018 meeting were made. Posted minutes are considered final based on lack of comments.
- V Old Business -- Activity and Electronic ballots following the Orlando meeting:
 - a. The previous meeting closed with approval from the WG to reject all remaining editorial comments and submit to Revcom.
 - b. Based on an issue raised in PC37.04 and PC37.09 WG's it was requested a small change be made to C37.12 to clarify that certain capabilities were optional rather than mandatory and could be included by the user in the purchase specification.
 - c. An electronic ballot of the WG was circulated and the change was approved 14-0 with 6 members not responding.
 - d. Following a recirculation for the above change one negative ballot was received in the phraseology although not the intent of the change. A vote of the WG voted to approve the change 11 1 with 8 not voting.
 - e. Recirculation 5 drew four new negative comments which were out of scope for the recirculation. The balloter approved the document regardless and marked the proposed change with "must be satisfied" = "No". The WG voted 18 -0 with 2 not voting to reject all four comments; the balloter agreed with the rejection.
 - f. Draft 5.4 from Recirculation 5 was submitted to RevCom on 12 Oct and is on the 4 Dec. agenda.
- VI New Business: A quorum was not present to separately affirm the activities from the electronic ballots, however both a quorum and majority of WG members voted for the actions by electronic ballot. The WG chair requests that the HVCB subcommittee confirms the RevCom submission.
