Main points:

The proposed agenda for the meeting was approved by the WG members (motion by Lukas Zehnder, second by Jean-Marc Willieme). There were no new topics or items presented by members of the WG to add to the agenda.

The IEEE copyright and patent policy slides were shown to the working group. There were no questions, patent claims, or additional discussion on these slides.

The minutes of the previous meeting were discussed and were then approved by the working group (motion by Lukas Zehnder, second by Jean-Marc Willieme).

Mirko Palazzo informed the WG that FDIS are expected to be due/submitted by mid-November of 2020.

The WG reviewed the revisions made by the IEC editors. These revisions were mostly editorial and were typically accepted by the WG, but the following revisions were discussed in more detail:

- Revisions to the Foreword regarding historical details and list of changes made in the new version of the standard were partially accepted and revised based on the discussion in the meeting.
- Revisions to the Scope were rejected by the WG
- Dates of reference documents throughout the standard were reviewed and revised based on the IEC editor comments
- Terms and Definitions were reviewed and revised based on the IEC editor comments
 - \circ This included replacement of () with < > in the main term title
 - Lukas Zehnder proposed to modify the definition "making or breaking unit", which was seconded by Jim van de Ligt and accepted by the WG.

The review of the revisions and comments from the IEC editors was not completed in this meeting. Mirko will distribute the remaining comments for the WG to review and come prepared to discuss at the next WG meeting.
