1. Approval of the Fall 2020 meeting agenda.

Mike Lafond moved and Paul Barnhart seconded that the Fall 2020 meeting agenda be approved as submitted. The agenda was approved unanimously.

2. Approval of the Spring 2020 meeting minutes.

Russell Boyce moved and Bob Cohn seconded that the Spring 2020 meeting minutes (rev 3) be approved as submitted. The minutes were approved unanimously.

3. Welcome and member attendance

The meeting was called to order by Ron Hartzel, Chair at 8:05 AM (CDT). Ron welcomed the members and guests. A total of 47 participated; 25 - C37.20.3 members and 22 guests. Quorum threshold was met.

4. Introduction of members and guests

Member introductions were conducted, the attendance was compiled utilizing the MS Teams conference participant list along with the printed meeting roster. The final attendance was also validated against the MS Teams chat window which captures when participants joined the meeting.

5. Recognize and posthumously honor Mr. Allan Morse

Ron Hartzel, C37.20.3 Chair recognized and honored the working group and career contributions of Allan Morse (past chair of this C37.20.3 WG). Allan was a Senior Member of the IEEE with 34 years of involvement, 22 of which were also with the IEEE-SA. A moment of silence was also observed.

6. IEEE-SA Patent Policy

Slides were reviewed that covered the IEEE-SA patent policy during the meeting.

No claims or issues were raised at the C37.20.3 Working Group meeting.

7. PAR change identified

During discussions related to section 5.2.3/Table 1 "Preferred voltage and insulation levels for MEI switchgear", it was determined by the WG that a PAR scope change was required to align C37.20.3 with the other standards with regards to maximum applicable voltage.

8. Update C37.20.3 Document Status

An updated version of the standard, C37.20.3 D2b, was distributed to the working group prior to the meeting and then reviewed during the meeting. The C37.20.3 D2 Consolidated comments spreadsheet was used to structure the review of standard version D2b. The disposition of comments outlined in the C37.20.3 D2 Consolidated Comments spreadsheet were agreed to as documented (rejected, revised, accepted, etc).

There was extensive discussion related to rain test alignment amongst our applicable standards C37.100.1, C37.20.2, and C37.20.3. Terry Neighbours had created a comparison spreadsheet that had been distributed to the WG prior to the meeting and was included with the overall D2 consolidated comments. That document was very instrumental in helping the WG determine the best approach for the rain test items in C37.20.3 section 6.2.8. Some of the rain test items were accepted due to existing alignment, but in general it was agreed to adopt the results of the currently active C37.20.2 WG.

9. Next steps

The chair will update the D2b draft standard per the group's feedback and accept all changes to date that were discussed and approved by the group. The chair will circulate the document along with the updated comment resolution matrix and a new comment spreadsheet over the winter so that new comments may be submitted and compiled prior to the Spring meeting, April 18th thru 23rd.
