C37.100.1 Common Clauses WG

- Of particular interest to HVS is the proposed change within C37.100.1 to change the altitude correction back to the previous values as in C37.30-1992 where the correction begins at 3300 feet = 1.00. A pole of the WG confirmed unanimous support for this change. Carl Reigart, Chair of WG PC37.30.1 will investigate whether this altitude correction change can be included in the current draft revision or should be a future amendment or corrigendum.
- Frank DeCesaro, Carl Reigart and John Webb are members of a task force under C37.100.1 reviewing references to tolerances. Frank requested that the HVS Subcommittee and Standards Working Groups review two tolerance documents that were distributed in an email by Bill Hurst after the meeting. Comments are to be sent to Frank by 1/31/22 with the WG Chairs taking the lead: C37.30.1 Carl Reigart, C37.303 Danny Hoss and C37.30.4 Bill Hurst.
