different characteristics, some of which are more like molded-case and insulated-case breakers and additional study will be required to make sure the standard is applicable to breakers which may require self-protection due to their withstand rating. Those may exhibit dynamic impedance caused by unintended intermittent arcing caused by electromechanical forces within circuit breakers where the short-circuit withstand rating is lower than the short-circuit interrupting rating. A PAR has been written, document title, scope, and purpose are unchanged from the current document. The PAR was shown to the group and discussed. It was approved without changes by unanimous consent.
