**a.** C37.13: *K. Flowers* 

The working group for C37.13 met on Tuesday morning. There were 16 members and 12 quests in attendance.

The ad hoc group formed to coordinate with SCC21 on voltage tolerances in the IEEE Std 1547.x series was unable to meet due to COVID and coordination issues. They remain engaged and the goal is to meet this summer.

An ad hoc will was formed to harmonize continuous current test requirements between C37.17 & C37.20.1. The group consists of 13 members from C37.13 & C37.20.1.

An ad hoc was formed to review the EMC testing requirements referenced in the standard (currently C37.90.1 & C37.90.2) with an eye towards an adopting alternate solution of UL489 Supplement SF & SG which reference a legacy version of IEC 60977-2.

**b.** C37.17: *J. Mizener* 

The WG met on Monday afternoon, there were 18 members and 9 guests – quorum was met. Draft 5 had been previously circulated, and 33 comments were received. The majority of the discussion revolved around the downloading of firmware to trip units and whether trip units should prohibit updating firmware when the circuit breaker is closed and in service. It was decided to have a meeting in the next few weeks to finalize the wording for the next draft.
