

**Minutes of High Voltage Switches Subcommittee Meeting

**Greetings and Introduction**

**WG PC37.30.1 – IEEE Standard Requirements for AC High-Voltage Air Switches Rated Above 1000 V**

- Jacob Blake was appointed as the new WG Chair of PC37.30.1 after Carl Reigart is retiring and stepping down.

**WG PC37.30.6 – Guide for Electric Motor Operators Applied to High-Voltage Air Switches Rated Above 1000 V**

- Jacob Blake, the Working Group Chair reported.
- One session was held on April 18, 2023. See the published minutes of the meeting.
- The meeting focused on comment resolution. It is planned to have the re-circulation ballot proceed by mid May 2023.

**WG PC37.30.7 – High Voltage Air Switches Over 1000 Vdc**

- Development of the initial draft standard is continuing.

- There are two ongoing projects. The open gap project intends to have a draft ready for the next meeting. The switchgear aging project has completed 90%.

- Carl Reigart and Laura Reid, HVS representatives to the WG gave a summary of the meeting held during the Spring 2023 Meeting.
- The meeting did not meet quorum.
- Discussion of altitude correction and pollution are of particular interest to HVS.

Pete Kowalik, member of the study group, indicated that the group is working on TRV potential.
