 - a) The original document was co-sponsored with the Substations Committee with the Switchgear Committee as the lead. This needs to be re-established for this amendment (pending approval from SA and agreement from Substations K0 WG)
 - b) The draft amendment was reviewed and the scope and several sections were revised to clarify "polyphase" and "Multi-phase" designs.
 - c) The need to clarify the requirements for refilling of MEGIS and subsequent field tests was discussed, and it was determined that an Ad Hoc was needed.
 - d) The discrepancy related to the need for pressure gages, indicatiors, and alarms was discussed, and it was determined that an Ad Hoc was needed.
 - e) P. Barnhart volunteered to lead an Ad Hoc with D. Mitchell, E. Byron, H. Milnikel, J. Leopard, G. Sims, and K. Ashtekar to draft revised text for both issues.

 - a) Vice-Chair will create a revised PAR and request Switchgear Assemblies subcommittee approval to submit to RevCom.
 - b) Dave Mitchell will reach out to K0 WG chair in Substations Committee to alert of our intention to include them as co-sponsors of the document.
 - c) Vice-Chair will attend K0 meeting in May to get formal agreement from Substations committee and present status of amendment.
 - d) Ad Hoc led by P. Barnhart will provide proposed draft text for clause 6.14 related to refilling and monitoring requirements for review at the Fall meeting in Sand Diego.
