- W.G. agreed to keep the additional text to § 5.5 for additional review.

- W.G. agreed to add the term *Three-phase* to the short-circuit test on the samples after the endurance test § 8.2.6
- W.G. agreed to remove the texts from § 6.7 Interlocks and use the same language used in C37.13.
