8 8	Key issue Although the PARs would be in the Scope of other three (3) different Standards Committee, the common group of Entities members handled these three (3) PARs request to be managed by a single Standards Committee. IEEE-SA and the IEEE PES Technical Council is proposing that one of the PES Standards Committees take the oversight for the revision of these three (3) documents and WG's.  As Switchgear has strong interest in the P1861 standard, the request is to have the Switchgear Committee agree to be the Primary Sponsoring Standards Committee for the revision of all three (3) of these standards.  The Switchgear Committee had already agreed (Spring 2023) to be the Primary Sponsor for the revision of P1861.  The request is for approval by the Main Committee (a motion and second and discussion will be required) to be the Primary Sponsor for revision of all three (3) documents.  Why the urgency? Goal is for the PAR's to be submitted prior to the NesCom September 13, 2023 deadline. Although there is some flexibility with the details for the PAR, the recommendation by the PES Technical Council for a single Standards Committee to be the Primary Sponsor is needed ASAP – if at all possible, prior to a meeting with the Entity Group on Tuesday August 29, 2023.
