2. Comment #140 – Table 2 – Line 464

- a) Additional information from the commenter:
 - 1) My concern is having two ratings based on switchgear applications. The table 2 is interpreted as derating the equipment because of a lower rating in Std386.
 - 2) The Std386 has removed DC withstand the test and values in the last version of the standard but left the AC withstand value.
 - 3) My point is that the Table 2 Column 4 rating values could be AC values as mentioned in Std386 Std.
- b) One recommendation is to refer to other standards (IEEE 386 elbows terminations).
 - 1) Note 2 to be revised to call out the ratings of IEEE 386 when the equipment includes IEEE 386 interfaces.
 - 2) There was some discussion about the impact of the lowering of ratings from previous versions to this version.
- c) A question was raised about the values from lines 1-4 vs 11-14 and the fact that a 36kV / 145kV BIL unit is tested to 70kV but a 38kV/ 150kV BIL unit is tested to 50.
 - a. F. DeCesaro to confirm this is not an error.

3. Comment #30 - 7.11.2.2

- a) Question of if the new language aligns with C37.100.2? No, the RODE ad hoc created language for C37.74 and C37.63.
- b) The document needs to be reviewed to ensure that where appropriate both line and cable charging needs to be called out. Example 7.12.2.2.5 (3 operations have restrikes during the combined line charging and cable charging...)
 - a. Discussion of if line and cable charging are both required (like with C37.60) which is 3 restrikes with the combined line and cable charging.
 - i. In this standard, both the line charging and cable charging are optional ratings.
 - b. Final language was determined to be "three operations have restrikes during the combined line charging and cable charging"
- c) It was noted that the rated voltage and current are called out in Table 3 but the # of operations are not called out.
 - a. **F. DeCesaro** to add columns to Table 3 for the # of operations at a quantity of 20 for each line.
 - b. It was suggested to align with Table 8 of C37.62 and incorporation the C1/C0 requirements. The WG agreed and in addition, the C1/C0 will be removed from the figure.

4. Comment #126 - Table 5

- a) Definitions for Immunity and Susceptibility were added and accepted by the WG.
- b) Subclause 6.4: Added reference to C37.68 and an elimination of the statement "where radio links". This was accepted by the WG.
- c) Clause 6.4 has requirements, but there are no tests called out in C37.63 to provide confirmation.
 - a. C37.68 has (3) subclauses which cover immunity and susceptibility. Language should be added to C37.63 Clause 7 to call for the appropriate testing.
 - b. Request for an ad hoc to review the language in C37.68 and determine if it should be inserted/ referenced in C37.63. P. Found, M. Feltis, C. Hastreiter to review and propose language by October 20, 2023.
 - i. F. DeCesaro will send out a letter ballot for approval of this language.

- d) It was mentioned that Table 5 will need to be modified to call out the new tests. After discussion, the new tests will be added to Group 4.
- 5. Comment #195 6.10.1 Line 626
 - a) The WG reviewed the suggested language and made slight modifications to allow for the "preference" of specific color.
 - b) It was shared that in C37.74 review, it was recommended that the indicator subclause include the note from C37.62 Clause 6.6. The WG agreed.
- 9. Other Business?
 - a. Motion for submitting latest draft to SA for recirculation ballot
 Rokser made motion was made to submit Draft 6 to SA for recirculation ballot with the inclusion of the approved language for clauses 6 and 7 from the ad hoc group. K. Darko seconded.
