1. Call to Order

6. Document Status Report

Jared mentioned that the new C37.23 PAR, which was formally approved by NESCOM on September 23, 2020, expires on December 31, 2024.

- Suggested changes from this Ad-Hoc group were presented, which involved separating this section into two sections: one for "switches" and the other for "links".
- Jared noted that this section may need to reference IEEE C37.20.4
- A comment was made as to whether wording should be added to reflect the need to provide easy access and accessibility.
 - Another related comment was made that substations frequently require a "visible gap" in electrical equipment to be present before it can be accessed (opened) by personnel.
- Overall, it was decided that this Ad-Hoc committee should continue meeting during this next period before the Spring 2024 meeting with the following members:

 - o Branko Knezevic
 - o Bryan Tatum

8. New Business

- The following comment was made regarding NFPA 70 ®: National Electrical Code ®, Article 370, Cablebus:
 - This Article references the CSA C22.22 No. 273 Cablebus standard but does <u>not</u> reference IEEE C37.23 (the standard for this WG).
 - Other comments related to NFPA 70:
 - This standard is updated every 3 years.
 - It is too late to get any changes into the 2026 version.
 - Eddie Wilkie will investigate how potential changes to future NFPA standards could be presented.

Mark Roberson noted that he sent with this meeting's notice the following documents:

- Latest C37.23 draft standard (D2)
- Updated C37.23.D2 "Comments" file to be returned via email with any comments.

Jared reviewed (along with WG discussion) **Comments #15 – 20** in the file that were returned since the last meeting. However, since there were still **Comments #21 – 29** remaining that were <u>not</u> reviewed due to the WG meeting time ending, <u>a separate virtual meeting</u> will be scheduled by Jared before the Spring 2024 WG meeting to go through these remaining comments.
