Meeting Minutes

1. Call to order and introduction:

The PC37.016 WG IEEE Standard for AC High Voltage Circuit Switchers Rated 15.5 kV met on Monday, October 6th, 2025, at 3:45 PM Neil McCord, Working Group Chair, presided over the meeting.

2. Introduction of Members and Guests

Attendance recorded through sign-in sheet (attendance sheet attached to MOM).

• 54 in attendance with 30 of 34 members (88%) present. Quorum met.

3. Review of Copyright, Patent, and Behavior/Ethics Slides & Call for Patents

Chair called for any potential Patent claims. No Patent claims identified.

4. Discussion on Draft D2.6 for C37.016

WG chair continued discussion on three-phase verification tests.

WG chair proposed that a three-phase test is not needed for close and latch if it passed the single-phase test. Discussion followed with comments made that the three-phase close and latch test is required. Comment was made that previous and existing versions of C37.09 do not require the three-phase close and latch test.

Comment was made that the making withstand current should be the same as short time withstand current since the circuit switcher can close into a fault. Table 15 needs corrected to show this.

Existing C37.016 Clause 5.16 calls it rated short-circuit making current, comment was made to use consistent language in this clause.

Motion made to make the change to make short-circuit making current the same as the short-time withstand current: Andy Chovanec, 2nd to motion: Zachary Beecher, WG approved

Motion to add close and latch requirements to three-phase verification tests (TPVm1 and TPVm2): Dan Schiffbauer, 2nd to motion: Dave Mitchell, WG approved

WG Chair mentioned adding a requirement for no-load test. No objections raised by WG.

Comment was made that we should add clarification to what is meant by "adjustment" during the test. Discussion of WG clarified that three-phase test should be performed first, and then during single-phase tests that follow the "adjustments" can be made to match three-phase performance (i.e., travel curve). Primarily for hydraulic or pneumatic mechanisms (maybe some spring) where adjustments can be made.

Motion to accept the modified language regarding the "adjustment" as shown on the screen during the meeting: Motion: Carl Schuetz, 2nd to Motion: Pete Marzec. Approved by unanimous consent.

WG Chair made a comment regarding what does "a significant influence" mean in 7.14.2.8. Discussion among WG about was would cause the influence (e.g., gas pressure buildup, electromagnetic forces, etc.). No proposals made to modify this during the meeting.

Informal vote on whether draft D2.6 is ready to initiate ballot: Consensus was to proceed.
